

DINSHAW MEHTA replies to KERSI RANDERIA of Parsi Times

So the cat is out of the bag. Last week I had sent out messages on WhatsApp (as I do not have the same facility and monopoly of both Parsi papers Parsi Times and Jame-Jamshed that Kersi Randeria has) to the community and BPP Trustees congratulating them for the helpline and volunteers set up by them to look after the needs of the Seniors and needy of our community in this pandemic times. I had informed the community of the cancellation of the HPY program of May 2020 as well as the May Queen ball of Rustom Baug. In my message I had pointed out the difficulties the residents of Godrej bldg at Contractor Baug, Mahim as well as Bhabha Sanatorium at Bandra were likely to face during the monsoon if repairs were not started immediately after the lifting of the lockdown. Trustees were also requested to arrange for permission to transport Baval firewood from Talasari to Nana Chowk, Trustees were also requested to look after the needs of those Mobeds who could not work in Agiaries due to its closure. And by way of passing I had remarked that while all Trustees were working unitedly as a team, one Trustee through his paper Parsi Times was trying to project only

himself in his game of one upmanship and requested all Trustees to put aside their egos and work harmoniously together for the poor and needy of our community.

Instead of informing the community on the above important issues and what steps the Trustees were contemplating to ease the hardships of the residents of Godrej bldg and Bhabha Sanatorium, or for transporting Baval from Talasari or how to help the jobless Mobeds, this self centered Trustee Kersi Rand eria as Owner of Parsi Times ignored all the major issues and found only my advice to put aside ego and work harmoniously and unitedly as a team instead of projecting only himself in his game of one Upmanship worth answering in Parsi Times of 19-4-2020.

Obviously his inflated ego was so badly pricked that he used the full front page of his Parsi Times newspaper to try to salvage his bruised ego against my frontal attack of his one Upmanship against his colleague Trustees. In fact if one were to Question his colleague Trustees to reply the truth with their hand on their heart all except perhaps ND would endorse my charge that he desperately tries to project only himself to he exclusion

of others on all issues and matters of the community. In fact Rand eria himself has more or less admitted that he delivers his responsibilities collectively as a team member of the Board and also individually as an elected Trustee.

Mr Randeria, all Trustees have to work as a team and all decisions and actions have to be taken as a team by the Board of Trustees and not as an individual Trustee. If seven Trustees were each to work individually, there would be chaos and confusion within the BPP staff and the community. Kersi Randeria further admits my charge of his game of one Upmanship against his colleague Trustees when he invites all community members to directly mail him with any queries, suggestions, grievances or feedback. My charge is proved.

Mr. Randeria, you should invite all community members not to mail you directly but to mail to BPP as a whole Board as ultimately it is the Board who runs the BPP and not Randeria alone or any other Trustee alone.

But this is not the time for one Upmanship and I hope the rest of the Board work harmoniously and unitedly for the greater good of the community.

As regards Bhabha Sanatorium,

ex-Trustee Jimmy Mistry has shown the way to solve the terrace problem. Godrej bldg residents will have to brave this monsoon in their bldg unless the Trustees offer some other alternative. Several Truckloads of Baval wood have arrived at Ness Baug godown of M/s Sidhwas in this week thanks mainly to Viraf Chiniwala. As regards Mobeds, again Jimmy Mistry had persuaded Nusli Wadia to give Rs 75 lakhs from BPP's own account of Wadia Baugs for their needs for three months. But once again Kersi RAnderia vetoed this proposal, I guess, because than all credit for mobed amelioration would go to Jimmy Mistry. How truly selfish can one be? Neither Jimmy Mistry nor I are interested in becoming Trustees again (and probably both would win hands down) but that does not mean that we abondon our community or that we cannot advice or suggest what is in the larger interest of the community. Mobeds are an integral and most important segment of our community and their welfare should be of paramount importance and not throw them to the end of the line as Randeria has done.

FULL FAMILY OF SERVANTS OF 72 YEARS OLD SINGLE SENIOR ROSHAN GHADIALI CONTINUES TO OCCUPY HER FLAT G-7 AT BHARUCHA BAUG

In the Parsi Juction issue of 21-04-2019, we had published an appeal letter dated 22-12-2018 from Roshan Ghadiali, a 72 year old spinster residing alone with her servants, complaining of harassment from her servants and requesting Trustees help to remove the servants from her flat. Her appeal was supported by another letter signed by ala the residents of G block.

However nothing has since been done by the Trustees to stop this harassment of a Parsi beneficiary by her servants. who are now proliferating due to the busy schedule of the Trustees from their infighting and one upmanship to take corrective action.

On 2-11-2019, the residents of Bharucha Baug sent another letter to the Trustees complaining of no action being taken though the servant Mrs. Hira Eshwar Patel, her son Nihil and his wife continue to reside in G-7 and harass and torture Roshan Ghadiali. But the BPP administration and our Trustees

continue to be just mute spectators to this biatant trespass.

In the Parsi, Junction issue of 29-12-2019, we published another letter dated 26-12-2019 from the residents to Trustee Viraf Mehta, with copy to Parsi Junction, complaining of the misuse of our Trust properties by servants of senior single residents and requesting quick action or face the same problems like Sharda Sonavane of Khareghat Colony. The letter also informed of another case of a servant Mumtaz residing in Multistorey bldg D-3/33 along with 3 more Muslim men as paying Guest in the seniors flat with request to take urgent action and not repeat the same mistake as in the case of Sharda of Khareghat Colony.

The Trustees with all the resources at their disposal have to take urgent steps to keep control over their property or the servants will soon gang up and trespass into all residences occupied by single seniors. In fact out of the box thinking is what is required through the recently formed Consultative Committee to keep this problem from spreadingto other residences.

Will the Trustees stop their interse disputes and get down to their role of managing their Trust property. It is a sad state of affairs that Kersi Randeria after having neutralized Jame-Jamshed by purchasing its Editorial rights ensures that the community is kept in the dark of all the murky dealings of his majority Trustees. Parsi Times publishes all inane matters but refuses to publish any letters deemed detrimental of the Trustees even if true and factual or answer the various issues raised by this paper. Kersi Randeria uses his Trusteeship as an office to make profit through his paper Parsi Times.

Allotment of Flats is published as paid advertisement only in Parsi Times and not in the really Parsi community paperJame-Jamshed. Thus all the hundreds of needy

applicantsare forced to purchase every week the Parsi Times paper in the hope that their name will be published as a successful allottee of BPP flat thus indirectly enhancing its readership. 'k95tk

Hydroxychloroquine and its connection with India

As most of us are already aware, Hydroxychloroquine has already taken the world by storm. Every newspaper is talking about it, and all countries are requesting India to supply it.

Now, a curious person might wonder why and how this chemical composition is so deeply entrenched in India, and is there any history behind it.

Well, there is an interesting history behind it which goes all the way to Tipu Sultan's defeat. In 1799, when Tipu was defeated by the British, the whole of Mysore Kingdom with Srirangapatnam as Tipu's capital, came under British control. For the next few days, the British soldiers had a great time celebrating their victory, but within weeks, many started feeling sick due to Malaria, because Srirangapatnam was a highly marshy area with severe mosquito

The local Indian population had over the centuries, developed self immunity, and also all the spicy food habits also helped to an extent. Whereas the British soldiers and officers who were suddenly exposed to harsh Indian conditions, started bearing the brunt.

To quickly overcome the mosquito menace, the British Army quickly shifted their station from Srirangapatnam to Bangalore (by establishing the

Bangalore Cantonment region), which was a welcome change, especially due to cool weather, which the Brits were gavely longing for ever since they had left their shores. But the malaria problem still persisted because Bangalore was also no exception to mosquitoes.

Around the same time in 18th century, European scientists had discovered a chemical composition called "Quinine" which could be used to treat malaria, but it was yet to be extensively tested at large scale. This malaria crisis among British Army came at an opportune time, and thus Quinine was imported in bulk by the Army and distributed to all their soldiers, who were instructed to take regular dosages (even to healthy soldiers) so that they could build immunity. This was followed up in all other British stations throughout India, because every region in India had malaria problem to some extent.

But there was a small problem. Although sick soldiers quickly recovered, many more soldiers who were exposed to harsh conditions of tropical India continued to become sick, because it was later found that they were not taking dosages of Quinine. Why? Because it was very bitter!! So, by avoiding the bitter Quinine, British soldiers were lagging behind on their immunity, thereby making themselves vulnerable to Malaria in the tropical regions of India.

That's when all the top British officers and scientists started experimenting ways to persuade their soldiers to strictly take these dosages, and during their experiments, they found that the bitter Quinine mixed with Juniper based liquor, actually turned somewhat into a sweet flavor. That's because the molecular structure of the final solution was such that it would almost completely curtail the bitterness of Quinine.

That juniper based liquor was Gin. And the Gin mixed with Quinine was called "Gin & Tonic", which immediately became an instant hit among British soldiers.

The same British soldiers who were ready to even risk their lives but couldn't stand the bitterness of Quinine. started swearing by it daily when they mixed it with Gin. In fact, the Army even started issuing few bottles of Gin along with "tonic water" (Quinine) as part of their monthly ration, so that soldiers could themselves prepare Gin & Tonic and consume them everyday to build

To cater to the growing demand of gin & other forms of liquor among British soldiers, the British East India company built several local breweries in and

around Bengaluru, which could then be transported to all other parts of India. And that's how, due to innumerable breweries and liquor distillation factories, Bengaluru had already become the pub capital of India way back during British times itself. Eventually, most of these breweries were purchased from British organizations after Indian independence, by none other than Vittal Mallya (Vijay Mallya's father), who then led the consortium under the group named United Breweries headquartered in Bengaluru.

Coming back to the topic, that's how Gin & Tonic became a popular cocktail and is still a popular drink even today. The Quinine, which was called Tonic (without gin), was widely prescribed by Doctors as well, for patients who needed cure for fever or any infection. So, that's how the word "Tonic" became a colloquial word for "Western medicine" in India.

Over the years, Quinine was developed further into many of its variants and derivatives and widely prescribed by Indian doctors. One such descendent of Quinine, called Hydroxychloroquine, eventually became the defacto cure for malaria, which is now suddenly the most sought after drug in the world today.

And that's how, a simple peek into the history of Hydroxychloroquine takes us all the way back to Tipu's defeat, mosquito menace, liquor rationing, colorful cocktails, tonics and medicinal
