Dear Community Members

This is a request to all community members who have not been vaccinated to please enrol and get vaccinated at the earliest. This is paramount to your own safety and for that of your family and friends.

It is upon each of us to ensure that the community is completely vaccinated with both doses before we can lower our guard. Today colony residents have become lapse because they feel the second wave is over. However, I implore everyone to please maintain all safety precautions and social distancing norms. Our colonies are slowly opening to outsiders and hence anyone from allowed is permitted in which can lead to the spread of the virus once again.

Community members who have taken their first vaccine dose are requested to please take their second dose of Covishield after 84 days and no later than 114 days and for Covaxin after 28 days. It is each person's duty to be responsible for themselves and take the second dose at the correct time.

In the first phase of our ongoing efforts get our community vaccinated, over 12 colonies participated in getting their residents their first shot, especially for those 18+ which has been hard to get. Now, along with the first shot we can also get slots for those requiring their second shot, provided the current stipulated 84 days has passed.

Like previously, if you live in a colony, please contact your association and share your details. If you live in a private building, please call the BPP Covid helpline and share your details.

The BPP has a help line which is functioning every hour – every day. Community social workers activists are shuttling community members to get vaccinated. I plead with every community member to please take full advantage of these services at the earliest. This will ensure that there is no untoward incident in any colony or any home.

Once again a Big Thank You to the B.D. Petit Parsee General Hospital, courtesy the CEO, Lt General (retd) Dr Manomoy Ganguly, VSM as well as Masina Hospital, courtesy the Joint CEO Behram Khodaiji, for their extraordinary efforts towards vaccinating our community. Parsi General Hospital's magnanimous generosity must be applauded as it continues to vaccinate any and every Parsi/Irani Zoroastrian for FREE. If you're going to PGH, a sincere appeal to those who can afford to, please pay for the vaccine by leaving the amount as a donation in the donation box. Of course you are most welcome to donate more if you'd like to.

A big thank you once more to our BPP Staff and community social workers who have, regardless of the situation, been available to help each and every community member.

PARSI COVID deaths consigned at Prayer Hall, Worli from March 22, 2020 till June 11, 2021

We have obtained the list of names of Parsis whose cause of death was the Covid pandemic from March 2020 when the first death occurred on 17th April 2020 of Sarosh Jamshed Patel. Since all the names with their sagai have already been published in Parsi Times from date to date we are not repeating the full sagai or address.

But a monthwise analysis as per the list shows that in April 2020 only 1 Covid affected Parsi was consigned to Prayer Hall next in June 2020 7 were consigned July 2020 5, August 2020 4, Sept 2020 8, October 2020 13, Nov 2020 5, December 2020 2, Jan 2021 1, Feb 2021 2 and March 2021 3.

Thus during the whole year of 1-3-2020 to 31-3-2021 there were 51 Parsis who died due to Covid.

However the Second Wave which started in Feb 2021 was most frightening as 38 Parsis died due to Covid in April 2021 and 14 Parsis died in MAY 2021.

Thus 52 Parsis died in two months of April and May 2021 compared to 51 deaths in the earlier 12 months. Since June 2021 figures are incomplete we will not consider it at present.

We give below the names of Parsis whose cause of death was Covid and consigned to Prayer Hall Crematrium for the Period 1-4-2020 to 31-5-2021. The BPP can update and delete these names from the electoral rolls to avoid any misuse.



Collapse of Grand Paradi Podium on 17th June 2021 Causing Substantial Injury to Cusrow Baug Resident



On Thursday 17th June 2021, Cusrow Baug resident of Block E-1, Mr. Khushrow Minoo Boyce whilst leaving his clients residence on Dadisett Hill, behind Grand Paradi after repairing her TV suffered serious injuries to his ribs and forearm when the slab of the podium and compound wall of Grand Paradi crashed into his scooter, seriously injuring him and making a total loss of his scooter.

He has been admitted at Breach Candy Hospital with fracture to his nine ribs, left hand 3 fractures and forearm badly injured with flesh fully exposed with a gaping cavity as can be seen from the attached photos, which will require two-three sessions of plastic surgery. He is the husband of Zenobia Boyce, a very efficient steno sincerely and silently working in the office of BPP.

Trustee Viraf Mehta on hearing the news of the accident to Zenobia's husband immediately contacted Zenobia offering his services to Zenobia who was frank enough to reply that at present everything is being looked after by the family and friends including dentist Dr. Merwan Farog.

The Grand Paradi Society have been good enough to pay

Rs. 1 lakh deposit to the Hospital and we hope that his full medical expenses will be paid by the Society but what about compensation for the immense pain and trauma Khushrow is going through.

In January 2021 the Society was prosecuted by the BMC for not carrying out required repairs to bring the podium to a safe condition. We give below the writeup reported in Mumbai Mirror of 29-1-2021 of the prosecution lodged by BMC on the Society.

The Grand Paradi cooperative housing society at Kemps Corner, home to some of the richest businessmen of Mumbai, found itself in a soup after the BMC filed a case against it in the metropolitan magistrate court for not reinforcing its podium which is in 'ruinous condition and likely to collapse', posing a danger to residents as well as passersby.

Grand Paradi comprises of 14 row houses and three 26-storey buildings. Below the podium is the society's parking space. The society is home to Smita Crishna Godrej; Arun Diwan Nanda, executive director, Yes Bank; Gautam Doshi, managing director, Reliance ADAG; Rani Kapur, former mother-in-law of actress Karisma Kapoor, and Avinash and Niranjan Naik, sons of the late chief minister, Vasantrao Naik.

The BMC's application, which names the society, its chairperson Jyotsna Tanna and secretary Sachin Sheth as accused, states that no attempt was made to repair the plazalevel podium despite a notice being served to the society in July. Two inspections conducted in July and September had revealed that chunks of concrete at the bottom of the beams supporting the podium had fallen off at several points, while exposure of the reinforcement to the atmosphere had led to corrosion. Moreover, it said that the podium did not comply with fire department norms as it could not withstand the weight of the fire brigade's latest engine, which has a 90-metre hydraulic fire ladder that can reach 30 floors, weighing a whopping 51 tonnes.

Chief fire officer, P S Rahangdale, told Mirror, "The podium needs to be strengthened in a way that it can take the weight of the new fire engine. Otherwise there is a possibility that the podium could collapse under its weight."

The civic body was acting on complaints made by two residents of the society, NM Shah and late NN Bhagwati, both structural engineers themselves.











"My biggest concern was the safety of the residents. It is a disaster waiting to happen. In case the podium collapses, it will affect the building, the row houses which are situated on it, as well as the parking underneath. A structural consultant approved by the society's managing committee had, while renovating the podium, made two major blunders. One was reducing the height of the T-shaped beams supporting the slab by 3 inches, reducing their strength by 40 per cent. Second was the reuse of used, rusted steel reinforced bars of 1974," alleged Shah.

In July last year, Mirror had reported that, after inspecting the premises, the BMC had served the society a notice under section 354 of the Mumbai Municipal Corporation Act, giving it 30 days to reinforce the podium or build a new one altogether and set up a fence to protect passersby and the surroundings from any damage.

It also stated that only the entrance bay of the podium was supported by heavy girders underneath, while the exit portion was not. However, an inspection in September revealed the society had failed to fulfil these recommendations.

Devidas Kshirsagar, assistant commissioner, D ward, said, "The society failed to comply with the requirements despite a notice, hence they were prosecuted as per section 475A of the MMC Act." The maximum punishment under this section can be three years' imprisonment and a fine of Rs 50,000.

The first hearing of the case is scheduled for February 18. The society's chairperson Jyotsna Tanna said, "We will be putting forth our case during the hearing. Reinforcing the podium is going to be an extremely tricky procedure as per our architect. It will have an impact on the entire area of the society."

Dear Sirs,

Incident on 17th June 2021 on private road of Monte Rosa Re.:

As you are aware, we act on behalf of Mrs. Hilla Homi Dadysett who is a senior citizen of 98 years. We have to record that on 17th June 2021, a large section of cement structure/construction overhanging our clients private road which leads to her bungalow and the overhead scaffolding came crashing down on the said road. There was no safety net and the work had stopped for several years with no steps taken by the society to ensure its safe completion, despite several reminders from our client and her staff. As per a report in the Mumbai Mirror of 29th January 2016 (enclosed), the Brihanmumbai Municipal Corporation had warned the Society of the disaster waiting to happen. The crash and cement slabs that fell were so bad that it severely injured a gentleman viz. Mr. Khushroo Boyce (also a senior citizen) who was visiting our clients house to repair her TV, who fell off his scooter with the impact and was severely hurt. The pictures of the crash and the substantial cement slabs and scaffolding that fell, annexed hereto are self-explanatory. You will notice that Mr. Boyce's scooter is also a near total loss.

Till the time of writing this letter and pending the various MRI scans and tests being performed on Mr. Boyce, including RTPCR tests, the doctors of the Breach Candy Hospital have ascertained that Mr. Khushroo Boyce, has broken several ribs, has multiple fractures to his left arm and wrist and a substantial

portion of flesh on his arm has been ripped off and the open wound is full of cement shards, which will require plastic surgery. Pictures of arm injury are enclosed herewith for your reference. Once the reports of the MRI and other tests are completed we will no doubt inform you of the same.

We may point out that providentially our client and her staff were not hurt in this mishap that has occurred purely due to the negligence of the members of your society/committee, despite being warned by the Brihanmumbai Municipal Corporation, who have not cared to take sufficient precaution on the repair/construction exercise, that has been pending and remains incomplete for several years and despite our client and her staff also pointing out their safety concerns on several occasions.
