Dear Community members,

My colleagues Kersi Randeria and Noshir Dadrawala have taken to the media to defend their arbitrary stand on insisting the BPP announcing a date to hold elections at a time they are well aware, the SOPs do not permit holding of the same. Unfortunately only selective information is being shared by them to mislead the community into believing that as majority Trustees we are causing harm to them.

Allow me to provide you with a short and accurate update on what has transpired over the last two weeks.

- On Tuesday October 5, Hoshi Jal and Anahita Desai along with a few supporters met the Board of Trustees to push for immediate mid-term elections for two seats with a 7 year term applicable to their elections.
- Kersi Randeria and Noshir Dadrawala supported this stand. In fact, the individuals who attended the meeting were mostly employees of Kersi Randeria or Anahita Desai.
- Following them stating their request, they were asked to come a week later after the Board had a chance to deliberate on the points raised by them
- At the meeting on the following Tuesday, Oct 12, at 5pm, Dr. Zuleikha Homavazir, Rumy Zarir and Pheroze Amroliwalla along

with likeminded supporters visited the Board and put forward a strong rationale for holding elections for 5 seats together in October 2022. Their rationale seemed to be:

- (i) to save the BPP Rs. 40 lakhs to hold elections for two seats now and instead to hold elections for five seats in October 2021 together (BPP currently has Rs 11 crores in outstanding payments).
- (ii) amend the term of Trustee from 7 years to 5 years by seeking to amend the prevalent Scheme of Elections. This was not acceptable to Kersi Randeria and Noshir Dadrawala as they continued to insist on wasting much needed BPP money to hold mid-term elections.
- (iii) Avoid risking an election at a time when COVID is still rampant in colonies and in Mumbai and the August 2021 SOPs have yet not been further modified in regards to elections.
- The meeting with Dr. Zuleikha Homavazir, Rumy Zarir, Pheroze Amroliwalla and their supporters was fruitful and positive.
- Next at around 630pm Hoshi Jal and Anahita Desai along with their supporters revisited the Board. They were requested to wait outside to allow the Trustees present to deliberate on what the previous group had said as well to make a final decision.

- After discussing at length the views of both sides, the Board passed a resolution by majority to move for an amendment of the scheme to reduce the term of a Trustee from 7 years to 5 years. It was also recommended to hold election for 5 seats in October 2022 after following due process as required.
- Once the decision was made, Hoshi Jal, Anahita Desai and their supporters were called back into the Board room and the decision was then conveyed to them. Noshir, upset at the decision made (which did not favour him), submitted his resignation to the Chairperson. Unfortunately the meeting took a turn for the worse with the supporters of Hoshi Jal and Anahita Desai starting to create chaos.
- What was even more shocking was the way Arzan Ghadially and Shahrukh Billimoria began yelling at us and also began to make disrespectful and derogatory statements against Chairman Armaity Tirandaz. When I tried to tell them that his was no way to speak not only to a senior lady but to the Chairman of the BPP, they showed no respite and continued to yell defamatory statements towards the Chairman. A recording of the entire meeting is available to hear the shocking manner in which these individuals have spoken to Mrs. Tirandaz. I am not surprised by this given that they are supporters of Kersi Randeria who has 4 criminal complaints against him including outraging the modesty of a woman, assault, cheating, fraud and forgery. Looking at this unacceptable behavior and yelling by a few individuals present, Chairman Tirandaz was forced to terminate the meeting.

It is to the credit of the Chairman Armaity Tirandaz, a soft spoken and noble lady that she has not filed a police complaint against them for outraging the modesty of a lady and the least the community expects from them is an apology to the First citizen of the community.

You will recall that from 2015-2020, Yazdi Desai was Chairman and Kersi Randeria, the ad-hoc Chairman, enjoyed a majority on the Board along with Noshir Dadrawala and Zarir Bhatena. The then majority Trustees took no steps to amend the Scheme even though the same was promised during their election meetings in October 2015.

- Adv Berjis Desai had given the Board a draft back in 2016 but despite several reminders from me and at times from Kersi too, the majority (including Kersi) NEVER took it forward.
- When probed further by Dr. Homavazir, Noshir Dadrawala took responsibility for this lapse and apologized for the same. He stated that now that he thinks about it, he has regrettably made many wrong decisions as a Trustee of the BPP.

that the Board, under the Now Chairmanship of Mrs. Armaity Tirandaz wants to amend the scheme. Kersi Randeria and Noshir Dadrawala are opposing it. In fact Kersi Randeria at a recent Board meeting very openly stated that the amendment would be unfair to Hoshi Jal and Anahita Desai. Trustees are meant to work in the interest of the Trust, not in the interest of the candidates they

On the other hand candidates like Rumy Zarir and Dr. Zuleikha Homavazir have stepped forward to not only help the BPP save Rs. 40 lakhs but also steer it in the right direction to amend the Scheme of elections, something which the majority has only given lip service to.

They are also in agreement with us to amend the term of a Trustee from 7 years to 5 years for all subsequent elections, including their own. This is direct contrast to candidates like Anahita Desai and Hoshi Jal who are not thinking of the Trust but themselves and want elections now only for two seats with a 7 year term even if that means the Trustees coming 10 months later in Oct 2022 get a 5 year term.

Ever since Mrs. Armaity Tirandaz has become Chairman, Kersi Randeria with the support of Noshir Dadrawala have only been putting forward road blocks in the Board and the progress of the BPP. Instead of helping raising funds for the BPP, they squander more charitable funds on meaningless litigation. A while back I asked Noshir Dadrawala what his contribution was to help raise funds for the BPP, he had no answer.

Here's a chronology of events this year:

January 2021 - Chairman Tirandaz announced elections for two seats to be held on 14th March 2021.

February 2021 - second wave of the Corona pandemic in begun to pick up and the Trustees were considering various options.

March 9, 2021 - Board resolved, by majority, to postpone the elections due to a spike in Covid cases and moved the High Court for postponing the March elections.

March 10, 2021 - Kersi Randeria, Noshir Dadrawala and Anahita Desai moved the High Court against this decision. The Court did not entertain them and help in favour of the decision of the majority Trustees.

March 12, 2021 - Kersi Randeria, Noshir Dadrawala and Anahita Desai went in appeal before the Division Bench of the High Court. A consent order was passed where March elections was postponed to May 2021. This was agreed by the Trustees UNANIMOUSLY.

April 7. 2021 - the Board of Trustees UNANIMOUSLY moved the Chamber Judge to postpone the May elections given the second lockdown.

July 2021 - after the second lockdown restrictions started to relax, the Board of Trustees UNANIMOUSLY set the date for elections for October 2021.

August 2021 - BMC announced SOPs with restrictions on election meetings, election rallies and electioneering. Hence the Board, by majority, moved the date of elections to Nov 2021.

The SOPs above in regards to elections and electioneering have not been relaxed since August 2021.

Hence elections could not be announced till date. Now given we would have two elections within 10 months of each other, it was the right view to not only save Rs. 40 lakhs for the BPP but move for amendment of the scheme. Otherwise the community will not have enough time to amend the scheme even for the October 2022 elections.

If the community has noticed that ever since Mrs. Tirandaz has become Chairman of the BPP in Jan 2021, Kersi Randeria has been misusing his Parsi Times and is constantly being critical of the Board. He does not miss an opportunity to wash dirty linen in public. In fact he has very brazenly started leaking minutes of our meetings to support his biased views. But what he will not reveal is that the problems being faced today by the BPP are the culmination of mis-management by Majority Trustees that he was part of from 2015-2020.

I have repeatedly asked my colleagues to work together to help improve the BPP but instead week after week Kersi Randeria choses to wash dirty linen in public through the Parsi Times and Noshir Dadrawala, instead of being a team player, decided to step down as a Trustee.

I am sure their whatsapp warriors will make another vicious attack yet again on me and my family, but that is to be expected. That is not going to deter me from doing what it right by the community, by the BPP and by the beneficiaries.

THE RESIGNING TRUSTEE

In yesterday's Parsi Times of 16th Oct 2021, Noshir Dadrawala has given a two page monologue as to why he was "Submitting My Resignation As Trustee of BPP Was The Only Honorable Option!"

While his resignation letter dated 12th Oct 2021 was unconditional, we are informed that he has now made it conditional by first discussing the legal validity of the alleged Resolution of postponing elections for two seats and wants the Board to declare the date and program of elections. Mr. Dadrawala should realize the resolution has not only been passed but notice to the Charity Commissioner has already been given.

A quick trip down memory lane:

In 2008, Noshir Dadrawala became a Trustee of the BPP for the first time. Within three years in April 2011, Noshir Dadrawala resigned from the BPP citing "Serious differences" with the other Trustees on the BPP Board.

Noshir Dadrawala mid-2015. announced his candidature for the October 2015 elections. Within a few weeks he pulled his candidature stating

"I cannot compromise with crooks to achieve political ends. Sorry, but, let the community get the leadership it deserves."

He later on changed his mind once again and stood on a platform alongside Kersi Randeria and Zarir Bhatena.

In April 2018, Noshir Dadrawala once again resigned from the BPP as he was humiliated by the Chairman in front of staff members. His resignation however was not in the format prescribed in the Scheme of Elections. Noshir wrote

"I am aware that the scheme of election states that a letter of this nature should be addressed to the chairman. But, sorry that is a position he holds by 'default' and not because he deserves it."

Mr. Dadrawala claimed that this was not the first time that Mr. Desai had humiliated him in front of others, including BPP's staff members and the trustees. "His high-handed, arbitrary actions are by now well-known to everybody," Mr. Dadrawala wrote."I re-contested in 2015 to give my very best one last time with a new team. But, it was a huge mistake on my part. This board is just as bad as the previous one, perhaps much worse! It is beyond redemption."

Noshir Dadrawala never re-submitted his resignation letter in the format prescribed in the Scheme of election and continued as a Trustee of the BPP.

We are also reliably informed that a few weeks ago at another Board meeting, Noshir Dadrawala began penning his resignation yet again when Kersi Randeria snatched the pen away from him and made him stop.

Lets take a look at the Irony of the statements made by Noshir Dadrawala.

He insists that there should be seven Trustees and any vacancy should be filled within 90 days. Yet he denied Muncherji Cama to attend BPP for over three years on a false Change Report filed by Yazdi Desai to avenge his wife's defeat.

Though at one point he tried to withdraw the patently trumped up Change Report, he did not take it further on Kersi Randeria's instructions. Even when Late Zarir Bhathena was in and out of Hospital for the major part of his term, except for a few months there were never seven Trustees but only five or six.

For the first few years of their term Armaity Tirandaz and Viraf Mehta were treated as Untouchables and denied access to anything at the BPP. The majority Trustees, of which Noshir was a part of, threatened all staff NOT to give any Minutes, files, Documents and any other papers to Armaity Tirandaz or Viraf Mehta or else they would lose their job. Ultimately Armaity Tirandaz and Viraf

Mehta were forced to move the High Court which ruled in their favour and restored their rights as

Trustees but not before they had to spend lakhs towards legal costs from their own pockets whilst Kersi Randeria, Yazdi Desai and Noshir Dadrawala shamelessly charity funds to pay their legal fees to the tune of Rs. 70 lakhs. Where was Noshir's sense of Justice at that time?

When Kersi decided to give his business partner's relative a flat in Godrej Baug for a mere Rs 8 lakh donation despite the BPP having an offer for Rs. 60 lakhs for the same, Noshir was part of the decision to allot this flat. Where was Noshir's sense of Justice at that time which cost the BPP Rs. 52 lakhs?

When Kersi convinced the majority Trustees to allot flats out of turn to Karyesh Patel and Kaikashroo Irani despite them having alternate accommodations, Noshir was part of that decision. Where was Noshir's sense of Justice at that time?

When Kersi convinced the majority to pay Rs. 35 lakhs to his "consultant friends" for the ownership building at Godrej Baug, Noshir was part of that decision. The majority have paid falsely almost Rs.5 cr in taxes on that building when we could have moved Court against this levy in under Rs. 4 lakhs. Where was Noshir's sense of Justice at that time?

When Kersi convinced the majority not to auction flats for the first four years of this Board, Noshir was part of that decision. Today, the BPP is facing a financial crunch because of that decision. Where was Noshir's sense of Justice at that time?

Noshir by himself is a very logical person, kind and soft hearted but in presence of Kersi Randeria he is a totally changed man. An example

of that is when he had agreed with late Parvez Driver, having coffee in Gaylords, to reduce the additional Service Charges from Rs. 750/ pm to Rs 350/pm. Even Zarir Bhathena, Viraf Mehta and Armaity Tirandaz had agreed. In spite of Majority agreeing, Kersi Randeria was able to dissuade Noshir not to reduce the increased service charges.

Ultimately in July 2020, the full service charges of Rs. 750/ pm was waived by Armaity Tirandaz, Xerxes **Dastur and Viraf Mehta.**

Noshir admits that Zarir Bhathena expired on 24th June 2020 and because of Covid pandemic no elections were held within 90 days nor was Court moved for extension. Yazdi Desai suffered a stroke in April 2020 and could not attend office after that and Anaita Desai submitted his resignation on 23rd December 2020. Armaity Tirandaz then officially was elected as Chairman and it was proposed to hold elections for two vacancies on 14th March 2021.

Noshir Dadrawala proposed two consensus candidates -Berjis Desai and Anahita Desai. Unfortunately the Second wave of Covid Pandemic started in early February 2021 and kept on increasing daily due to which the Trustees decided on 9th March 2021 to move Court to postpone the Elections for the safety of the elders of our community.

Noshir falsely alleges that the Trio tasted its first triumph in terms of might is right. Several facts were kept hidden from the community. It was not the Trustees who postponed the elections but the High Court did it in view of the Covid pandemic and Govt. SOPs.

This has deliberately not been mentioned by Noshir in Parsi Times. On 10th March 2021, the High Court was moved for postponing the March 21 elections.

Unfortunately instead of all Trustees the postponement, Trustees -Noshir and Kersi opposed the postponement and Anaita Desai intervened to also oppose the

postponement. The High Court ruled in favor of the postponement due to **Covid Pandemic.**

Since Berjis Desai refused to file an application to oppose the postponement and to support them, Kersi Randeria started terrorizing Berjis and warned him not to stand for elections and he would ensure his defeat which led Beriis to withdraw from the March 21 elections making it clear that he would never contest as long as Kersi Randeria is on the Board and only if he is not a Trustee will he offer his services in the interest of the community.

Being dissatisfied with the High Court order, the two Minority Trustees then went in appeal to the Division Bench Where it was mutually accepted to fix 21st May 2021 as the day for the elections of these two vacancies. However since the Second Wave was at its peak, all the Trustees moved the Court for postponement of the May elections which was allowed by the High Court even though the date was fixed by the Division Bench.

When things started to improve in June-July 2021, it was decided to hold the elections in September-October 2021. But on 6th August 2021, the BMC and Govt issued guidelines that no elections be held, no meetings or campaigning will be allowed. In view of the August SOPs, the Trustees decided to await its withdrawal or variation and decided to hold elections in November 2021.

However the said August SOPs have not been withdrawn as yet and hence since now the elections can be held only in January 2022 as more than two months time is required from its announcement to date of elections it was decided to move the Judge in Chamber to reduce the term to 5 years which should have been done long back when Randeria and Noshir were ruling the roost.

If it had been moved in August 2021 when Zuleika Homavazir first reminded the Trustees about reduction of term than by December2021 we could have had the elections but due to their obstinacy to hold elections for Anaita and Hoshang Jal with seven year term that everything fizzled out to have same terms for all seven Trustees.

Noshir alleges that might has become right and the three Trustees earlier in minority but now in Majority want to continue their rule. Parsi Junction would like to inquire of Noshir to point out one act of theirs that has been detrimental to the community at large or BPP in particular. We can point out a dozen lacuna whose advantage was taken by the earlier Majority but not a single one by the new Majority under Chairmanship of Armaity Tirandaz.

The present Majority when they came in power abolished the additional service charges of Rs. 750/pm being levied on all BPP flats. During Pandemic, it took the Cama Baug Kitchen and supplied free/ subsidized food to the needy and deserving, It gave financial help to unemployed Mobeds for six months. It did several Welfare activities for the poor and needy. It is discussing ways and means to convert Leave License to Tenancy with tax experts and lawyers.

Hence why is Noshir so critical that the present majority wants to continue in power. Noshir and his majority were in power for five years and this paper can enumerate at least 10 instances where this power was misused by Kersi Randeria and Yazdi Desai.

Armaity has proved to be a far better Chairman with her grace, her humility and her treat all in same way attitude than Yazdi Desai who was vindictive and vengeful and gave complete abandonment of his duties as Chairman to the undeserving Kersi Randeria who has brought BPP to its worst financial crunch in its 300 year old history.

All the above facts have very conveniently been denied to the community so as to paint a twisted version to the community. The correct facts are as stated above and not the garbled version published in Parsi Times.

Through her editorial: "Wake Up And Smell The Conspiracy" she states

"WE **REALISE** THE RARELY VALUE OF OUR RIGHTS AND PRIVILEGES... AT LEAST **NOT** UNTIL WE'RE DENIED OF THESE."

Very well said madame! Where were you when the owner of your paper which boasts of a masthead 'The Truth. Delivered Weekly' bulldozed his way and operated as if the BPP was his personal fiefdom, all the while denying the then minority Trustees of their rights? Have you conveniently forgotten that the then minority of Armaity and Viraf had to get their rights restored by approaching the High Court at their cost?

You go on to say that "In India and the world over, we cherish the select reputation of being Parsi." This Parsi owner of your paper has in the eyes of Vikram Jagdale and others damaged this "sterling reputation" of Parsis by denying that Jagdale had paid Randeria 30 lakhs for booking a flat and then claiming it to be a loan which also has not yet been refunded to Jagdale nor Interest paid even after six years.

It must be remembered that this 30 lakhs was borrowed by

Jagdale to book the flat by selling/ mortgaging his ancestral property and himself taking a loan from employer Bhabha Atomic Research Centre Employees Credit society. What an Irony that a once Parsi headed institution like the BARC helped Jagdale to fulfil his dream of owning a home, Kersi Randera on the other hand cheated him under the umbrella of being a Parsi!

And talking about democracy, sorry to say that word does not figure in Randeria's dictionary, for it is neither practised by him in the BPP nor does he allow it in his own newspaper the PT. If he did, he would have, in all "fairness"printed dissenting views also, which is what media is all about in a democracy!

Further to avoid dissenting views even in his rival paper Jame-Jamshed he purchased the Editorial rights from its Owner at a hefty price.

CASH-STRAPPED B.P.P. THE CANNOT AFFORD TO HOLD TWO ELECTIONS, **EACH** COSTING BETWEEN 40 TO 50 LAKHS IN A PERIOD OF LESS THAN 9 MONTHS.

The gullible community was told that the B.P.P. is cash strapped and therefore in 2017 the then majority in the BPP led by Randeria and comprising Mr. Desai, Noshir and the late Zarir imposed a steep increase in Service Charges of Rs.750/- p.m. Was this steep increase levied so that community funds could be frittered away by having two elections within a span of 9 months? Has the cash flow suddenly improved that BPP should squander away the forcefully collected amount and spend almost a crore by holding two elections?

It is to be noted that the two candidates supported by Trustees Dadrawala and his co-panelist Randeria are keener to have the elections now, before the general elections in October 2022, as they fear that the term of the Trusteeship may be amended by the honorable Judge- in -Chambers to a five-year term and before that happens they would like to come in for a seven-year term. This appears to be their personal agenda not in consonance with the general interest of the community. A shorterterm is likely to make a Trustee more accountable to the voter.

Should an error committed nearly 15 years ago continue without being corrected?

Trustees have to work in the interest of the Trust and its beneficiaries and NOT in the interest of prospective candidates SOLELY with the hope

of garnering their support so that they continue to ride roughshod. During the meeting, it was argued on behalf of the two candidates by their supporting trustees that reducing the term to five years from the present seven would deprive them of two years in their term. These two years were essential as the new prospective candidates would need that time period to learn and study the working of the BPP. Learn and study at the expense of the community? Are you serious?

If these two worthies feel that a term of five years is too less to serve the community then even seven or ten years would not be enough. That itself speaks volumes for their ability.

And why may I ask are the two dissenting trustees championing the cause of these candidates when in the meeting of October 12, Noshir very equivocally agreed that he and his partner will both approach the judge in chambers to amend the term along with an enforceable code of conduct. If that be the case why the turnaround after the group comprising Zuleika Homavazir, Rumi Zarir and the undersigned showed with facts and figures that the community did not want to be saddled with a midterm election and only then left the board.

After reading the message from Parsiana, it is difficult to fathom, that after agreeing with the proposal made by the undersigned along with Ms. Zuleika, Mr. Rumi Zarir, two likely candidates, who accept a tenure of 5 years for trusteeship, to move the hon'ble Judge-in-Chamber to only amend the tenure of the trustees term from the present 7 years to 5

years before the next election in the presence of all including Mr. Patel from Parsiana, one is surprised at the flip flop.

Therefore the community implores that the BPP implement the resolution and approach the Judge-in Chambers to at least amend the scheme to this effect.

One of the cronies of Randeria constantly refers to the Chairman looking at Viraf as a teleprompter. May I remind him that during Chairman Yazdi Desai's tenure, the Chairman's gaze was only fixed on Randeria and Randeria was the ONLY spokesman with the then chairman keeping silent and having no role to play! Tables have now turned and that is the sole reason why these two through their proxies want to thrust an election on the gullible voters.

I thank all those who were present at our meeting on October 12, 2021 to support the worthy cause of not having an Election at this stage.

DR. ZULEIKA HOMAVAZIR SENDS LEGAL NOTICE TO TRUSTEES TO REDUCE TERM FROM 7 YEARS TO 5 YEARS

Aspiring Trustee Candidate Zuleika Homavazir had sent her mail dated 17th August 2021 to the Trustees to move Court to reduce term of office of a Trustee from seven years to five years as promised by all the Trustees when campaigning for the October 2015 elections. Till date there has been no response from the Trustees except mail from Noshir Dadrawala that Kersi Randeria had proposed it but it was not taken forward thereafter and pleaded guilty to not amending the Scheme earlier.

On 12th October 2021, Zuleika Homavazir submitted her Advocate R. M. Vanoo's 10 page Notice dated 11th October 2021 in BPP Office calling upon the Trustees to amend the Scheme to reduce the term of office of a BPP Trustee to five years under Clause 16 of the Scheme of Elections as promised by them in October 2015 as nowhere does anY elected office extend beyond four or five years at most before the next round of Elections commences first for PRESENT two vacancies, then three vacancies in October 2022, then one more in April 2023 and last one in July 2025. The legal Notice calls upon the Trustees to urgently move the Chamber Judge for amendment ONLY of term of office to avoid lengthy delaying arguments if several amendments of the Election Scheme were moved and till then no Elections be held and recommends holding Elections of all five Vacancies together in September/October 2022. The Notice further warns of taking appropriate action if the Trustees do not take cognizance of the Advocates Notice.

Along with this, Zuleika also submitted her letter dated 11th October 2021 wherein she has submitted the result of a Google Survey done by her of 3000 community members of whom only 261 responded in one day. According to her survey 73% were in favor of reduction of tenure of Trustees to five years before holding any elections. Further 73% were against holding elections for only two seats and want elections for all five seats in October 2022.

Subsequently a delegation comprising Zuleika Homavazir, Phiroze Amroliwalla, Mr. Firdosh Homavazir (father of Dr. Z. Homavazir), Mr. Rumy Zarir, Jangoo Doctor, Mr. Cyrus Bharucha, Mr. Neville Wadia, Mr. Behrooze Khushrovi, Mr. Astad Palkhiwalla, Mr. Kerfegar Panthaky, Mr. Shahrukh Govadia, Mr. Darayus Mistry, Ms. Nazneen Govadia, Mr. Aspi Billimoria and several others. met the Trustees with prior appointment.

Phiroze Amroliwalla informed the trustees that on one hand the community is informed that since 2016 BPP is facing a cash crunch but now the Trustees are ready to spend around Rs.40 Lakhs to Rs.50 Lakhs for election of the two seats, it does not make sense at all, hence it was a request that the Elections for the total five seats be held in October 2022 only.

Dr. Zuleika Homavazir, a prospective candidate for the forthcoming election was very categorical to reduce the term to five years before holding elections.

Rumy Zarir inquired why is the Scheme not amended as yet though promised in October 2015 to which Noshir Dadrawala pleaded guilty that though they were in majority for the first five years, amendment of the Scheme was not seriously considered nor discussed nor implemented. Noshir Dadrawala now wanted all Trustees to resign and have elections for seven Trustees. This would be unfair to those whose term of seven years is still pending and only five Trustees elections whose term would be expiring in October 2022 should be held in October 2022.

Even Kersi Randeria agreed for a five year term along with a Code of Conduct. But he was also for having elections for all seven Trustees to which Zuleika was categorical that it is for each Trustee to decide for themselves and nobody can force others before their term expires.

Phiroze Amroliwalla appreciated that half the Trustees had pleaded guilty for not amending when they were in power for five years. Only one amendment of term of office if moved unanimously by all the five present Trustees then Court would urgently allow it. He further inquired why they were advocating the cause of the prospective candidates -Hoshi Jal an Anahita Desai for getting a seven year term for them. This was an obvious clash of interest.

Viraf Mehta pointed out that they were in majority for five years but the amendment was not considered at that time except for just lip sympathy from time to time. He further informed that Noshir Dadrawala's earlier proposed consensus candidate Beriis Desai has opined that it would take around 3 to 4 months for amending just the term of Trusteeship. After the amendment the time would be very less and hence to save Rs. 40 lakhs of charity funds it would be advisable to postpone the elections for two seats till October 2022 whereby all five vacancies can be filled by just holding one election.

Dadrawala Noshir was against postponing the election and wanted elections to be held irrespective of the cost. Ultimately it was agreed by all for amendment of reduction of term as well as Code of Conduct.

The Group then left and the other Group led by Hoshi Jal and Anahita Desai in favor of holding immediate elections were called in and the whole scenario changed leading to resignation of Noshir Dadrawala. But with the pendulum one can never be sure as Kersi Randeria took away the resignation letter from the hand of the Chairman Armaity Tirandaz and now refuses to return it back to her on some lame excuse for giving a window to Dadrawala from which to escape.





It is believed that even after Chairman **Armaity** Tirandaz and Trustee Viraf Mehta left the Boardroom, this gathering continued to pass unparliamentarily remarks against them for quite some time along with Kersi Randeria and Noshir Dadrawala.

It is unfortunate that instead of talking out our problems in a civil manner, some politically motivated individuals stoop to such a disgraceful level in order to vilify our Chairman Armaity Tirandaz. What is more shameful is that Kersi Randeria and Noshir Dadrawala did nothing to stop these individuals from disrespecting a lady and the Chairman of the BPP. In fact Kersi Randeria was heard yelling in the background as well. Only Trustee Viraf Mehta stepped in to keep these individuals in check.

Here's a recap of a few of our Paid Communitiy Activitists on the payroll of Kersi Randeria who showed no respect to the Chairman of the BPP.

- 1) Arzan Ghadially Resident of Godrej Baug. He is a member of a sub committee of the Godrej Baug Residents Welfare Association. Allegations have been made against him for indulging in tax evasion and financial impropriety. Its been over three years and Mr. Ghadially has still not been able to prove his case. But Kersi Randeria will always defend him and use him as Arzan has very vocally turned against Dinshaw Mehta and his family. It has now come to light that Arzan is on the payroll of Kersi Randeria (of course Arzan will shamelessly deny it).
- Shahrukh Billimoria-Another resident of Godrej Baug and a committee member of the Godrej Baug Welfare Association. He has constructed an illegal balcony in his house and has blatantly told the Trustees he will not remove it despite several notices being sent. He has falsely added his name to his aunt's tenancy and now claiming rights in two flats.
- 3) Karyesh Patel-is a paid employee of Anahita and Yazdi Desai. He is also indebted to Kersi Randeria who

came to Court and fought for his case. Kersi Randeria convinced the majority Trustees to allot Karyesh a large flat in Dadar Parsi Colony even though he has the possession of his father's flat in Godrej Baug worth over Rs. 1 crore which has been kept locked and vacant for years on end. Karyesh's brother is married to an American citizen and lives in the US. Karyesh is also still in possession of a flat in Bhabha Sanatorium which was supposed to have been surrendered to the BPP when he was allotted a flat in DPC. With the blessings of Kersi Randeria he is able to hold on to three flats.

4) Kaikhushru Irani- lied to the BPP Board of Trustees that he was going to be homeless as he had lost the case with Petit Trust but in reality he had actually won. He was able to get away with this with the help and support of Kersi Randeria who convinced the Board to allot a large flat, out of turn, to Mr. Irani and his non-parsi wife. Kersi Randeria promised the Board he would reimburse the Rs. 40 lakhs which the BPP paid the outgoing tenant to get control of this flat but three years later and the BPP has not seen a single rupee in this regard. At present Mr. Irani is not only in possession of the NC Baug flat in Palmlands but also a second charity flat in the Petit Trust blocks in Balaram Street.

NOSHIR DADRAWALA RESIGNS FROM BPP

The BPP meeting on Tuesday, October 12, ended on a sour note. Chairman Armaity Tirandaz had to end the meeting prematurely as a few individuals accompanying Hoshi Jal and Anahita Desai began to get unruly and pass derogatory statements towards the Chairman.

However, before matters took a turn for the worse, Trustee Noshir Dadrawala hand wrote and signed his resignation letter addressed to the Chairman. He read out his resignation letter before the gathering and then handed it over to the Chairman Armaity Tirandaz. We are informed that in front of the gathering Kersi Randeria reached across the table and snatched the letter from the Chairman and kept it with him and refuses to return it back.

In the last 48 hours, Noshir Dadrawala has taken to social media to confirm his resignation and has sent out the below message:

"I read out my resignation and handed over my signed copy to the Chairman in everyone's presence. It was written by hand and I have no copy. It has yesterday's date, it is duly signed and properly addressed to the Chairman. The meeting ended soon thereafter. Noshir"

Number 5 in Zorastrian religion

How is number five important in Zoroastrian religion?

- 1. The word for number five in Avesta is pancha. This number has great significance in Zoroastrian religion, especially and most importantly because it is the number connected with Sarosh Yazad.
- 2. Sarosh Yazad presides over obedience and hence he looks after the 5 sense organs and their perceptions, on account of which, man either becomes virtuous or sinner.
- 3. Number five is also connected with the 5 gehs which are the five divisions of the day in Zoroastrianism. They are Havan, Rapithwin, Uziran, Aiwisruthrem and Ushahin.
- 4. Five are also the division into which the society is divided. In an ascending order, the are: Nm na "house", visa "village", zantu "town", dakhyu "country" and zarthushtrotem "world authority"
- 5. Five is also the number of the Gathas the divine songs of Zarathushtra. They are - Ahunavad, Ushtavad, Spentomad, Vohukhshathra and Vahishtoisht.
- 6. The ten days of the Mktad are divided into two periods of five days each. The first five days from roj ashtad to aneran are referred to as panj-i-keh "the lesser five days" and the later 5 days, which are named after the 5 gathas are referred to as paj-i-meh.
- 7. Five is also the number of thin metallic rods in the ritual implement of barsom when it is used to perform most baj-dharna rituals. Even in the ancient times a barsom with 5 sticks was used.
- 8. The five main virtues according to the Yasna are good thoughts, good words good deeds, obedience and righteousness. The five main vices are bad thoughts, bad words, bad deeds, disobedience and wickedness.
- 9. Five are also the geographical divisions among which the priests distributed themselves in the 12th century for professional reasons. They are: Sanjānā (from the river Dantorā to the river Pār), Bhagariā (from the river Pār to the river Tāpi), Godāvrā (from the river Tāpi to the river Narmadā), Bharuchā (from the river Narmadā to the river Māhi) and Khambātā (from the river Māhi to the river Sābarmati).
- 10. As to Yatha ahu vairyos and ashem vohus there is a tradition of saying 5 Yatha ahu vairyos in our prayers and rituals whenever Sarosh Yazad is to be invoked. We never recite 5 Ashem vohus.

Unknown Facts of JRD Tata

URAN AGIARY

Umrigar Agiary, Uran

The Umrigar Agiary in Uran was built in 1904, a 'Nhallo Aatash' (small fire temple) was built as a private initiative by Sheth Kuverji Adelji Umrigar and Sheth Khurshedji Adelji Umrigar. In the beginning of the 20th century there was a sizeable presence of Parsi community (around 800) in Uran. These families were mainly in the business of distilleries. Presently, only a handful remain. However there are regular Zoroastrian families visiting all year long, coz a special faith lives for this Agiary and its fire having fulfilled many wishes of its pilgrims.

This Agiary is located at Mora Bunder in Uran, a small fishing village across the harbour from Bombay. The agiary isn't far from the jetty, and one can walk towards this holy place with the landmark of a couple of houses on the way which are made to Parsi style.

Kersi Sooi is today the only recognised Parsi left in Uran. He looks after the agiary, though he is not a priest. He is now used to this job and has taken care of this holy place as his very own. His parents had come to Uran from Navsari to manage the sanatorium in the agiary complex.

The agiary fire is a dadgah, and therefore a normal religious Parsi could tend it too. So whenever the priest had to go to his home-town, he entrusted

the fire in the care of the Sooi family. The trustees didn't have enough funds, and neither the Sooi's nor the priest drew much of a salary. When the last priest quit, no one was ready to work for the pittance offered. Rather than let the holy fire die out, Kersi began to look after it. It was quite a struggle then for him and even today he is just about managing to pull it off.

The original trustees couldn't spare the time to manage the agiary and had handed over the trust to the trustee of the Bhiwandiwalla trust. Kersi had gone to meet him to discuss the future of the agiary, he was told categorically by Mr Bhiwandiwalla that the original trustees had not left enough funds to look after the upkeep of the whole premises. But, at very least they would make sure of a regular supply of wood for the holy fire. After his death though, even that dried up, and Kersi had to put out constant appeals for funds to the Parsi public.

More than anything, Kersi bemoaned the loss of Parsi properties through carelessness. None of the legal heirs to the Parsi properties here had papers to the houses. He claimed the navy was ready to hand over the dokhma, if we Parsis could prove ownership. But no one knew where the original title deeds were. The agiary lands would have been encroached too if Kersi wouldn't have stayed around and taken care of this holy place. He

has sacrificed his entire life for the service of this holy place which was initially started by his parents. He is married, but his family doesn't want to stay in Uran. They stay at Vashi, with his wife's parents."

With all these efforts around and a lot of sacrifice gone into the service of this holy place, including a lot of financial support extended by his ownself towards the upkeep of this holy place, which should rightly be called the URAN PARSI AGIARY with no trustees name attached to it; as in all these years there hasn't been any welcome trustee who has come forward to take the real responsibility of the upkeep of this Agiary. Therefore Kersi Behramshaw Sooi now appeals to all genuine religious minded Parsis and Iranis [Zorastians] around the world to kindly come forward and generously towards donate maintenance and upkeep of this Agiary as with passing age, Kersi is finding it extremely difficult to continue meeting ends towards the regular supply of wood for the holy fire as well as the much needed maintenance of the Agiary and its premises.

But now that Kersi is no more, the upkeep and maintenance of the Agiary falls to the care of Dosu Bhiwandiwalla as the sole surviving Trustee and we are sure Dosu will not fail the community but carry out his duty as a Trustee faithfully.

SUPREME COURT ON BATLIWALLA AGIARY AT TARDEO

Below is the last paragraph of the Judgment rendered by the Indian Supreme Court in the fraudulent sale of _aapri Paevitra Paak Makaan Batlivala Agiary_ in Mumbai.

One of the main conspirators and sly fox who worked behind the scenes was none other than the same *Maneck Engineer former honcho of GODREJ INDUSTRIES* who has been publicly identified as BPP Trustee Kersi Randeria's "GOD FATHER" for decades.

Maneck Engineer formerly of GODREJ Industries served as a Trustee and in concert with other Trustees attempted to sell Aapru Paak Makan Batlivala Agiary to one *Suresh Mehta of Astral Enterprises.*

...Suffice it to say that such a frivolous prayer could not have been entertained, and the order of the Joint Charity Commissioner is absolutely illegal. Learned counsel for the trust stated that it would be difficult to repay the money. When trust has obtained money, obviously it has to repay. Let trust repay the amount of Rs.2,95,00,000/to the developer. Considering the value of the property and *the arguments made on behalf of the trustees, we are of the view that the trustees were not up to the task of protecting the interest of the trust, and clearly colluded with the developer while entering into such an agreement for development-cum-sale.*

35. The order passed by the *Charity Commissioner as well as by the High Court is hereby set aside.*

The appeal is allowed with the costs of Rs.1,00,000/- to be deposited by the developer with the Supreme Court Advocates Bar Association Welfare Fund within six weeks from today.



ADEN FIRE SAFE AT LONAVLA AGIARY

The Flames of Faith

'Lhotse', Air India's Boeing 707 began taxiing on the tarmac and as the big aeroplane lost touch with the ground and became airborne, chants of Yatha Ahu Vairyo rent the aircraft. For, this was a very special journey, on a very special mission. Flying on board the chartered plane was a very, very special and important entity - Atash-e-Adaran.

This, then, is the story of a very important and almost miraculous chapter in the history of the Zarathustris. An event which took place in the life time of most of us. Join us as we 'fly' down to the Red Sea port of Aden, situated on the Arabian peninsula. Welcome aboard the 'Lhotse':

Parsees have always been adventurous and enterprising and many have gone to distant shores to seek their fortunes and, wealth and in a number of cases, settled abroad. In a few places they even build Fire Temples to cater to the religious and spiritual needs of the Parsee community settled on these foreign shores. One such Agiary was built at Zanzibar which, unfortunately, had to be closed down when Parsees left that place and the Atash Padsha there just 'died out'. Shanghai in China, too, had a fire temple, which also unfortunately had to be closed down when the communists took over China. Another Agiary in a foreign land was the one at Aden in the country of Yemen.

Aden, in those days, was a thriving trading post, a free port like Singapore. Located at a strategic point on the Arabian peninsula, it was the port ships passed through on their East to West - West to East journeys, via the Suez Canal. Aden had a large number of Parsees - around 1300 - and in the year 1883 they built an aglary there where the consecrated Atash was of Adaren grade. This aglary was built by the Cowasji Dinshaw family who

were In the business of shipping. This family also built a mosque for the local Mohamedan population which is known as the Cowasji Masjid and is still in use in Aden. There also used to be a Dokhma in Aden for the use of the Parsees.

In 1967, the British left Yemen and South Yemen turned into a communist country. Aden soon lost its prime position as an important trading post on both sides of the Suez. Business declined and a number of foreigners working there and contributing to its economy started leaving, too. So did the Parsees, many of them who had almost settled there moved back to India or to other places like UK, Canada, etc. Only a few Parsee families were left by the mid-seventies and they, too, were all set to leave.

With the advent of communism, the agiary, dokhma and their funds, etc. all became state property. With all the Parsees set to leave Aden, who would take care of the Atash? That's when Cowasjee Dinshaw, the great grandson of Cowaajee Dinshaw who had built the aglary and dokhma in Aden In the last century, decided that he would not let the Holy Atash, which had sustained and nurtured the community in this land away from home, just die away as the one at Zanzibar had. Most of the Parsees in Aden had prospered and done very well for themselves, and they strongly believed it was due to the blessings of the Atash Padsha. The Atash had provided them with spiritual sustenance and was an important focal point of keeping the community united, alive and energetic.

Cowasjee Dinshaw firmly believed that this Atash had miraculous powers. During the fight for ousting the British from Yemen, inspite of all the

bombings and destruction all around, the Agiary was never touched even by a splinter, leave alone the various bombs that were exploding all around it. Ultimately, in 1967, the British left Yemen and the communists came to power. Soon, changes began even in the business community and one by one the foreigners started moving out of Aden. Now with the impending withdrawal of the Parsees from this ancient Islamic and new communist state, wnat was to happen to our Holy Fire?

The first decision was that the Atash had to be moved out of Aden. Alternate places where it could be enthroned were considered. The first was in a Daremeher in Iran. When Cowasjee Dinshaw approached the head of the Zarthusti Anjumans in Iran, they expressed their willingness to receive the Atash. But they had two conditions. One, they would follow the Fasli calendar for all religious ceremonies and, secondly, they would not be able to keep the Varsiaii in the Daremeher. Both these conditions were unacceptable to Mr. Dinshaw. So the next alternative was explored. This was a House of Worship in London. But the London-based Parsees were concerned that since some smoke would emanate from the Fire, it would be difficult for them to enthrone the Holy Fire in London!

That's when Cowasjee felt that the best place for the Holy Fire to be would be in India where it would be safe, glowing and 'alive'. The next step was to obtain permission from the government of South Yemen to move the Atash out of that country. Being a newly formed communist regime, they were not exactly very understanding of religious sentiments. Cowasjee Dinshaw appealed to the government for permission to move the Holy Atash

to India. This was refused. He then appealed to Queen Elizabeth as the head of the Commonwealth, the World Bank as well as the Government of India.

There were no encouraging or helpful responses from Elizabeth or the World Bank. It was the Indian government that really worked hard in this matter. India, in those days was ruled by the late Prime Minister, Mrs. Indira Gandhi and the foreign Minister was Mr. Y.B. Chavan, the strongman from Maharashtra. A petition was sent to the Prime Minister and not surprisingly was favourably received by her. The Prime Minister asked Y. B. Chavan to take all measures possible to persuade the South Yemeni government to release the 'Holy Atash'. This was not as easy as it sounded. The South Yemeni government was not very keen to let the Atash be moved out of Aden, being communists and thus having little sympathy towards religious spiritual sentiments.

It took a lot of persuasion from the Indian Foreign Ministry, Y.B. Chavan and even Mrs. Gandhi personally, to make the South Yemeni government finally agree to let the Parsees move the Holy Atash to India, In a meeting of the Non Aligned Nations held in Colombo, Y.B. Chavan personally met the Head of the South Yemeni government who was also present there and once again pressed the case for the release of the Holy Atash to India. At last, the South Yemeni Government agreed and, indeed, it was a moment of joy and relief for the Parsees of Aden, The condition was that it would have to be moved out at midnight. This was agreed to by Mr. Dinshaw. But much more of trials and tribulations had to be passed through almost like a test through fire itself. Further permission had to be taken that the Holy Atash would not be viewed by any non-Zarthustis which, too, was granted very reluctantly by the then South Yemeni government, after a lot of persuasion on the part of our Foreign Ministry.

No sooner was this news known, then a fresh controversy broke out in the community, back home in India. There was a lot of debate on how the Holy Atash could be transported. Cowasjee Dinshaw approached Field Marshall Sam Manecksha to chalk out the best land route to transport the Holy Fire. Manecksha drew up a route, but that meant passing through Mecca and Medina, holiest cities of Islam. Now, this would not have been possible since no non-Muslims are allowed to even enter these two cities.

Also, from the Zarthusti theological and religious point of view, transport through land routes was ruled out as there is an injunction in the Denkard on carrying the Holy Fire over wide expanse of waters, and since one would have to cross a number of rivers, this would create a major difficulty. Also, from the practical point of view, even on a different route drawn up by Manecksha, this was not a very good idea. One, it would have involved taking permission from a number of different countries (all Islamic states) to move the Atash through their land. Even the best route would have taken at least two thousand kilometers be covered. How was the Atash to be tended to five imes a day, every day on a journey that would have taken months to complete by road? Also, how safe would our Holy Atash be from the prying eyes of curious, suspicious and even hostile locals? Plus, the logistics of the whole exercise would have been too cumbersome to carry out. One would need a set of very hardy Parsi-Zarthusti drivers and mechanics to drive and maintain the vehicle. Again, the route would be over very rough and dry terrain, most of it desert. All this seemed like a very improbable venture to carry out. Thus, moving over a land route had to be ruled out.

For the same reason (injunction in the Denkard), the sea route was discounted. Moving by sea would have involved carrying the Holy Fire on a ship and travelling from Aden to Bombay. But on this point the eiders, scholars and those learned in our scriptural matters expressed their strong disapproval. From the Zarathusti point of view, according to them the Holy Fire is not to be carried over the waters. This is because the sea unfortunately contains within its waters a lot of pollutants, like discharge from the ships and freighters. Transporting the Holy Fire over such impurities would be nothing short of sacrilege, amounting to defiling the Atash Padsha.

So, what other avenue was left but to fly the Holy Fire over to India. Have you heard Of carrying fire in an aircraft? From the point of security that was a highly dangerous thing to do. It could result in the loss of not only the aircraft but also the people escorting the fire. Yet as the concerned people thought about and debated on these issues, the more it became clear that this was the only way to transport the Atash. Thus the decision was taken to fly it to Bombay.

Thus Air India was contacted. Air India agreed to provide an aircraft on a charter basis. This was a Boeing 707. Air India by then had begun inducting 747s, the giant Jumbos into its fleet.

Now even an airline started by a Parsee does not routinely fly Fire - that, too, consecrated and of the Adaran grade. To transport this very special 'passenger' it was essential that purity and some religious injunctions be observed. One of the first one amongst these was that only Parsee Zarthustis be on board the aircraft. Thus Air India began the exercise of identifying only Parsi crew who would escort the Holy Fire. Capt. Sam Pedder was contacted and nominated for this religious adventure. For this, he was required to fly a few 707s of Indian Airlines to clock-in some more hours for flying a Boeing 707 as he had by now graduated onto the 747 Jumbo Jets, giants of the skies.

The Engineering department of Air India, under the supervision of their then Deputy Director of Engineering, Mr. N.S. Mistry, prepared a special urn to

carry the Holy Fire in. They also made a big box which would hold the urn. These were made of aluminium and other metals.

The configuration of the First Class section in the special Aircraft - Lhotse - had to be changed to accommodate the box containing the urn which would be carrying the fire.

Soon it was time for the Holy Fire to leave the shores of Aden where it had provided its light and protection, its blessings and goodwill to the faithful.

Just on the eve of the departure an unexpected problem arose. The police commissioner of Aden, who was a Muslim-turned communist, informed the remaining few Parsees who were looking after the Fire that he would be coming over the next day to personally inspect the Fire and the urn and the box that would be carrying it. No amount of entreaties that the Holy Fire could not be subjected to the gaze of a non-Zarthusti seemed to have any effect on him. The fact that permission was obtained that the Fire would not be viewed by any non-Zarthusti did not cut much ice with this person, who insisted on his demand on the grounds that the big box could be used for purposes of smuggling!

He announced that he would be there when the Fire was being moved out and the Fire be kept ready for his inspection or else he would not give any permission to move it out of the agiary premises. Imagine the state of mind of the four-five Parsees left behind. Here they were trying their best to protect the Fire to ensure its survival and journey to India and here was a thunderbolt from a man who seemed unsympathetic and stubborn. Would the sanctity of the Atash be preserved after it was 'inspected' by a non-Zarthusti? After all, there are esoteric reasons why this is forbidden. The Parsees prayed to Ahura Mazda, to the Prophet Zarathustra. They prayed to the Holy Fire itself and asked to be delivered from this impending catastrophe. At midnight there was a knock on the door of the agiary. The Parsees looked at each other with dismay and anguish. So the commissioner had come to defile our cherished Atash Padsha, they cried.

The door was opened with a heavy heart. Out on the steps stood a person and he had brought some news. The commissioner had just died, most unexpectedly! The Holy Atash was now safe from the eyes of those who need not gaze at it.

Soon afterwards, in a convoy the Atash was taken to the airport. The aircraft had just arrived from Bombay and the engines were not even switched off. No non-Zarthusti touched the aircraft. The aircraft had been sanctified with wellwater and taro. Cowasjee Dinshaw was aboard the same with the Head Priest of Udwada, Dastoorjee Kekobad Phirozjee, who had provided a lot of religious advice on the whole exercise and, of course, his moral support. There were five other priests on board, too. As soon as 'Lhotse' landed, two mobeds holding British citizenship rushed to the Agiary. By then Dasturjee Minocher Manecksha who had tended the Fire for many years at the Aden Agiary had offered Boi to the Fire in the Ushahin Geh, for the last time in Aden. From there the Atash was brought in its new container in a convoy to the airport. A pavi was built to ensure the sanctity of the Atash Padsha. The Yemeni government had provided motorcycle escort to the entourage. The Holy Fire was carried onto the aircraft. In a few minutes the aircraft, the engines of which were never switched off even after its long journey from Bombay, was taxiing and was soon airborne. History was made as live fire was carried in an aircraft which otherwise was a very dangerous thing to do. As the aircraft took off, the Yemeni officials gave it a 21-gun salute, the sounds of which were heard all over Aden. This truly signified an end of an era for Aden, The all-Parsee crew as well as the other Parsee escorts kept on chanting our prayers.

The mobeds who were accompanying the Holy Fire did the Padyab Kushti, Atash Niyaesh and other prayers. They often opened the box to offer sandalwood to ensure that the fire was still glowing and had not died out. They did this with regard to all due ceremonies and by reciting the necessary prayers. Opening container and feeding sandalwood to the fire at the height of 30,000 feet was, indeed, a very dangerous thing to do, as any flames escaping out could lead to a major explosion in mid-air due to the highly pressurized cabin conditions. Yet, every time, they opened the box to look at the Fire, they found it resting quietly, just glowing softly and serenely, the flames dancing gently, almost as if enjoying the unique journey.

After flying for almost four hours, the aircraft landed at the Santa Cruz airport, Bombay, at around 7.00 a.m. The airport was chock-a block with Parsees who had come to receive their Holy Atash from across the seas. With due respects, the box was slowly taken down the steps. A pavi was built around the container and Yatha Ahu Vairyo was chanted, ceremoniously. Dasturjee touched the ground of Mother Earth in thanksgiving for a safe journey and with a prayer on his lips opened the box. Lo and behold, the Fire that was resting silently by just glowing softly while in midair, now leaped a few feet, as if in sheer ecstasy. The Flames of Faith danced and swirled as they came in touch with the atmosphere of Mother India - the land that has been home to its devotees (the Zarathustris and the Hindus) since centuries. Here, in the land that has been home to the largest number of the world's great religions,

the Holy Atash Padsha from Aden at last felt at home - secure and safe.

The Atash Padsha was now taken to the Soonawalla Agiary at Mahim in a special luxury bus for being 'rested' for the new hours. This was taken under police escort. The Atash was offered Machi and Boi for the Havan Geh, and later in the Rapithwan geh, too. The Mahim agiary was packed with hundreds of ordinary Parsee-Zarthustis who had come to pay their respects to the Atash Padsha. Around 01.30 at noon, once again the Holy Fire was taken on board the special bus and this time the second Phase of this historical Journey commenced... to the Adenwala Aglary at Lonavala in the hills of the Western ghats. This is where the Atash would be enthroned.

A pavi had been created around the bus and a chain attached to it to maintain contact always with the earth. In an absolutely unprecedented move, the Bombay to Pune highway, one of the busiest land routes in the country on which Lonavala is situated, was closed to all traffic upto Lonavala from Bombay. A motorcycle escort was once again provided by the government of Maharashtra to the convoy. A number of Parsees followed the same in eight buses plus many went along in their own cars and vehicles (around 60-70 automobiles) and the route was lined with cheering Parsees, praying and expressing their gratitude to the Lord for the safe passage of the Holy Fire.

On 14th November, 1976, Roj Behram, Mah Khordad, YZ 1346, the Atash Padsha which was first consecrated in Aden in the year 1883 in the Adenwalla Agiary at Aden in Yemen, arrived at its new home, the Adenwalla Agiary at Lonawala, India.

With due ceremonies and prayers (Machi and Boi ceremonies in the Ujiren Geh) the Atash Padsha was installed in the specially created sanctum sanctorum next to that of the

original Atash Padsha of the Lonavala agiary (which is of the Dadgah grade). A jashan for thanksgiving was later conducted in the evening. Once again, the agiary was full Of devotees and the atmosphere was one of great joy and devotion.

The costs and expenses which ran into lakhs of rupees for the complete operation were borne by Mr. Cowasjee Dinshaw and his wife, personally. When this writer enquired with him what was the sum spent he very modestly declined to mention the figure. Such humility and modesty is so rare and thus praiseworthy especially in the times we live in today.

Today, both the Atash Padshas blaze forth in joyous glory. The Atash from Aden stands testimony to those brave souls who consecrated the Fire in a foreign land and had the foresight and courage to bring it to safety when times became difficult. The radiant flames of this Atash bear testimony to the miracles that the Lord keeps creating, strengthening the faith of the faithful and reinforcing the message of hope, courage, devotion, faith and perseverance.

There are some more messages in this story and one of these is that after the flight of the Zarthustis from Iran to India, India has been the only place where we, the Parsi-Zarathustis have been able to build and sustain our holy Fire Temples without any fear of these being destroyed, desecrated or defiled. Even in the much touted democracies of the West, we may not be able to build fire temples where only zarathustis are permitted entry. No matter whatever disadvantages and inconveniences one may face here in terms of systems, infrastructure, etc. (and these are felt by people of all races and religions here) we have lived here freely and prospered, too. Our places of worship are not in danger of being destroyed or closed down. Indeed, we need to think as to why our ancestors were guided (divine guidance, I firmly believe) to come to

India when they were seeking refuge and not go elsewhere.

Indeed, if there is talk of closing agiaries today, it is unfortunately within the community itself and stems from tragic issues like not having sufficient number of priests to tend to the holy fires in remote places like small villages and towns. But hold it just a moment here. The Adenwalla Agiary at Lonavala where the Atash of this story resides today is tended by just one priest, day in and day out. Dasturjee Marzban Gonda has to be heard reciting our prayers at this Fire temple to understand the devotion and love that Atash can inspire.

Also, it we use our minds and resources, the Lord will provide support and guidance. If a few determined individuals could fly down the Holy Atash under very trying circumstances, facing various odds, surely we, too, can look at the possibility of keeping the fires glowing in all our aglaries and daremehers.

The story of bringing over the Holy Atash from Aden to Lonavala is a true story, little known and heard but it has many lessons for us all. It all happened just twenty-two years ago! It is part of our history. The Iranians of old were not known for recording their history. This is, therefore, just a small and humble attempt to do so, so that this story of devotion and courage is not forgotten and also so that we keep learning from history and not become victims of being ignorant of our past.

May the various Atash Padshas in various Fire temples continue to blaze and glow with love and joy, power and radiance, showering their blessings not only on our numerically tiny community, but also on this land of Bharat which has protected and sustained us, socially, materially and spiritually.
