

Majority of Bombay Parsi punchavet trustees want chairman out



MUMBAI: Four of seven Bombay Parsi Punchayet (BPP) trustees have voted to file a no confidence motion against chairman

Yazdi Desai for allegations ranging from protecting a non-Parsi trespasser to promoting his wife as a "shadow chairman". The BPP is considered the largest private landlord in Mumbai, controlling around 5,500 community flats in Parsi baugs such as Cusrow Baug in Colaba.

Desai, who took over as chairman in 2011, said there is "no provision for a no confidence motion in trust law or in our trust deed". In the absence of such a provision, trustees voted to file an application against Desai under Section 41(D) of the Maharashtra Public Trusts Act, 1950, which deals with the removal of a trustee if there is evidence of misappropriation of trust property, moral turpitude, or disobeying of lawful orders issued by the charity commissioner.

"The trustees don't know the meaning of 41(D)," said Desai, who has no plans to step down. "It's only for a trustee who misuses trust property for personal gain and, in my case, there's no such issue. This is just a threat."

The vote was moved by trustee Noshir Dadrawala, seconded by trustee Viraf Mehta and supported by trustees Armaity Tirandaz and Xerxes Dastur. Trustee Kersi Randeria abstained while trustee Zarir Bhathena was absent when the vote was conducted.

"He was working completely against the interests of the trust and overruling board decisions and resolutions," said trustee Viraf Mehta. "He was threatening BPP staff and signing MOUs on behalf of the BPP without the board's knowledge and approval."

Dadrawala shared four main reasons for the no confidence vote: Desai registered a leave and licence agreement to industrialist Ness Wadia's secretary with just his signature and without informing the other trustees; he wanted to offer a non-Parsi trespasser an ownership flat worth Rs 1.5 crore; he took control of a BPP function and instructed staff to invite only certain trustees; and his wife is privy to all BPP data without being an elected trustee.

Desai rebutted these allegations. He said the decision to allot a flat to Wadia's secretary was agreed to by all the trustees except Mehta, who abstained; the BPP function was, in fact, a personal function for which he had borne all expenses; community members approach his wife because she is more helpful than Dadrawala; and the non-Parsi trespasser had already been offered a flat in Thane by the previous board of trustees, which is now undergoing redevelopment, and hence Desai offered her the Borivli flat in order to regain possession of the premium flat she currently occupies in Khareghat Colony.

The next step, according to Dadrawala, is that the trustees will take a legal opinion regarding the validity of the vote and figure out how to move ahead with Desai's ouster. "We will also have to seek legal advice on whether we should remove him as chairman or as a trustee," added Dadrawala.

This isn't the first time that BPP trustees have resorted to filing a 41(D) application against a chairman. One was filed against former chairman Dinshaw Mehta in 2013 and Desai said another is pending against Mehta's son and trustee Viraf Mehta. Dadrawala, though, said that has yet to be voted on.

"A no confidence motion against a chairman is akin to the impeachment of a president," said community blogger and activist Jehangir Bisney. "There needs to be solid grounds for it... A spat on social media between the chairman and another trustee cannot be the basis of the motion. Howsoever one may dislike the BPP Chairman, there must be fair play by following all laid down procedures."

Jehangir Patel, editor of Parsiana, a community magazine, added, "This is more a question of Yazdi Desai's autocratic style of functioning. He alienates people and does things that

the others don't like but I don't think going to the charity commissioner resolves anything. It just drags on and on. The answer has to be arrived at outside of the courts of law and the charity commission."

BPP Elections and Hoshi Jal



Hoshang Jal

We have been reliably informed that even after the fasting drama of a Noshir Dadrawala, Cusrow Baug resident Hoshi Jal has once again written to the BPP calling for early elections as he is desperate to stand.

Hoshang Jal, Trustee aspirant in waiting since 14th March 2021, ever since Kersi Randeria

removed Berjis Desai as the Consensus Candidate though proposed by Noshir Dadrawala, due to his not opposing the postponement of the March 2021 elections, has vented his frustration at the Trustees not holding the elections for the two vacant Trustee seats since December 2020. It is not understood why the Trustee aspirants do not move Court to enforce elections to be held for the two vacancies. Perhaps they are aware that present Govt. guidelines and SOPs do not permit elections or electioneering to be conducted and hence the favorite pastime of Trustee bashing is indulged in by various factions of the community.

After the resignation of late Yazdi Desai in December 2020, the Trustees led by newly elected Chairman Mrs. Armaity Tirandaz had declared in January 2021 itself that elections for the two vacancies would be held on 14th March 2021 and for which about 6 to 8 candidates had already shown their readiness to contest and Anahita Desai had even started her campaigning in a few BPP Baugs. However due to Covid 19 starting its second wave from early February, Trustees decided to move Court seeking its views whether elections be held as announced or to postpone it for a few weeks/months as may be advised by the High Court.

Unfortunately, Noshir Dadrawala (ND) and Kersi Randera (KR) opposed the move for postponement and got Anahita Desai and Kaikhushru Irani to join them to oppose the postponement. They requested Berjis Desai also to file application to oppose but since he agreed with the majority Trustees to postpone in view of the increasing Covid infection, he paid the penalty and was hounded out as a Consensus candidate by Kersi Randeria. The Court called

the BMC advocate and after taking his advice decided to postpone the elections in spite of severe opposition from ND and KR.

Being dis-satisfied with the single Judge's Order, the two of them went in Appeal to the Division Bench who also upheld the postponement and fixed 23rd May 2021 as the next date of elections and ordered the Trustees to go before the single Judge having jurisdiction for further orders. However once again the single Judge in March 2021 refused to obey the directions of the Division Bench in view of rampant increase in Covid spread and postponed sine die to await improvement of the pandemic. In July 2021 when things seemed to be improving and the Chairman decided to soon move the Court for permission to hold the elections, Govt. issued SOPs of 3rd August 2021 not permitting elections, electioneering, campaigning, holding meetings and rallies, etc.

As per information given by the Astt. Commissioner in October 2021, these SOPs are still valid and binding though they are expected to be withdrawn once the BMC elections are announced but till then 3rd August 2021 SOPs do not allow elections. Hence Hoshang you have every right to be frustrated but not at the Trustees as it is the High Court and Govt. SOPs which are responsible for not allowing/conducting elections.

As regards his advice to the Trustees of the BPP taking one of the below mentioned steps:

- 1) Filing Consent terms in Court and holding elections for the full Board of Seven Trustees by March 2022, as has been publicly and unanimously declared by the existing Board of Trustees. OR
- 2) Forthwith, announcing the elections for the two vacant seats on the Board.

We would like to point out that Consent Terms obtained by the blackmail tactics of ND, instead of moving the Court as advised by the Division Bench, would hardly be entertained by the High Court and that too by curtailing their terms and hence the only option left is to announce elections for two seats which can only be done after the 3rd August 2021 SOPs are withdrawn. Till then all aspirants will have to wait.

I am concerned for my client Ms. Zuleika Firdosh Homavazir residing at Flat No.10, Building No. 13, 4th Floor, Rustom Baug, Sant Savta Marg, Byculla Mumbai 400 027 and under instructions I have to address you as follows:-

1. My client states that you are well aware that she is a member of the Anjuman Committee of the Parsi Punchayet Funds & Properties, a charitable public Trust duly registered with the Office of the Charity Commissioner, Mumbai, hereinafter referred to as "the said Trust" for the sake of brevity. Her name is borne at Sr. No. 36270 on the General Register of Members of the Anjuman Committee.

- 2. My client states that she is a full time Professor/ Lecturer in the Wilson College, Mumbai and Head of the Department in the faculty of Business Management Studies therein. She is also a Ph.D in Business Management. Recently my client was adjudged as The Best Professor in Management by BBC Knowledge. As such my client is a respectable member of the Parsi community in the field of education and otherwise.
- 3. My client states that you are the sitting trustees of the said Trust who are inter alia bound and liable to take decisions under the Scheme for the Election of the Trustees as sanctioned by the Hon'ble Bombay High Court and/or amended and/or modified from time to time, inter alia, in the matters of holding/conducting elections of the Trustees and/or any vacancy arising in the Trustees by virtue of death or resignation of any of the Trustees.
- 4. My client states that you are also well aware that she has been one of the candidates eligible to contest the proposed bye-election arising out of arose two vacancies in the office of the Trustees of the said Trust. One, by the resignation of one of the Trustees

Mr. Yazdi Hosi Desai and the other by the demise of the other Trustee Mr. Zarir Manekshaw Bhathena.

- 5. My client states that the election and the holding of office of the Trustees of the said Trust are required to be made in accordance with the Scheme for the Election of the Trustees and Immovable Properties of the Parsee Panchayet of Bombay as sanctioned by the Hon'ble Bombay High Court, hereinafter referred to as "the said Scheme" for the sake of brevity. The said Scheme consists of detailed rules and regulations framed by the Hon'ble Bombay High Court and the same are subject to amendment as per the reasonable needs and requirements of the said Trust and its members with the sanction of the Hon'ble Bombay High Court.
- 6. My client states that the said Scheme for the election of the Trustees of the Bombay Parsi Panchayet was originally sanctioned by the Hon'ble Bombay High Court in the year 1910 and thereafter it has been amended from time to time by the orders and directions of the Hon'ble Bombay High Court in the various petitions and applications submitted by the Trustees of the said Trust as well as by the members of the Anjuman Committee for the purposes of interpretation and modification of the said Scheme. Accordingly the Effective Date of the said Scheme is the date on which the said Scheme has been sanctioned by the Hon'ble Bombay High Court. The said Scheme envisages the procedures under which suitable and reasonable modification can be sought from the Hon'ble Bombay High Court.
- 7. My client states that Rule 25 stipulates the period of holding office as a Trustee of the Bombay Parsi Panchayet for seven years from the date of entering upon office. Rule 25 of the said Scheme is reproduced herein as follows:- "Every person who shall have been duly elected to be a trustee after the effective date shall subject to Rule 22 hereinbefore contained continue to hold office for seven years from the date he/she enters upon office, but will be eligible for election unless such person shall be disqualified

under Rules 24 above"

- 8. My client states that the aforesaid Rule 25 of the said Scheme requires serious reconsideration as no office in the world and more particularly in India is held for a period of seven years. The Constitution of India also does not provide for any elected authority to hold office for a period of seven years. Even the Indian Public Trust Act, under which the said Trust is duly registered does not provide for any elected post holding office for seven years. Accordingly the holding of office of the Trustees of the said Trust for a period of seven years is contrary and inconsistent with any election process in India and/or otherwise in any other State in the World. The provisions of Rule 25 permitting the Trustees to hold office for seven years after their election is therefore completely unreasonable, unwarranted, bad in law, untenable and even ultra vires the Constitution of India.
- 9. My client further states that there is a general long-standing demand from the vast majority of members of the Anjuman Committee to reduce the term of office of the Trustees elected to be a trustee of the said Trust from seven years to five years. This preposition was also accepted in principle by the majority of the Trustees and repeated promises and assurances were extended by them to reduce the term of office to 5 years. The present term of office of the Trustees for seven years has completely failed to obtain accountability of these Trustees. Once elected to office the Trustees have not bothered about the general interest of the common Parsi and the members of the Anjuman Committee. In order to assuage such demands, the Trustees have been merely promising and assuring the members of the Anjuman Committee that suitable amendment and modification in the said scheme would be proposed by obtaining written requisition duly signed by the majority of the Anjuman Committee and submitting the same before the learned Judge in Chambers in accordance with the provisions of the said Scheme.

- 10. My client further states that in the general elections for the office of the Trustees held in 2015, the candidates as well as the elected Trustees in their election campaign and even otherwise duly accepted the wide demand of the vast majority of the Anjuman Committee and even promised to tender their resignation as Trustees after a period of five years in office. In their term of office the Trustees also promised and assured the members of the Anjuman Committee that they would take necessary steps as provided under the said Scheme for reducing the term of office of the Trustees from seven years to five years. However even though the term of office as per Rule 25 is coming to an end on October, 2022 the majority of the Trustees have neither tendered their resignation by the end of the five year in office nor taken any steps to submit suitable application before the Hon'ble Bombay High Court under the provisions of the said Scheme.
- 11. My client further states that in pursuance of the demand of the members of the Anjuman Committee, the Trustees also brought in the agenda for reducing the term of office of the elected Trustees and held discussions in the various meetings of the said Trust. It is learnt that minutes in respect of such discussion as to the reduction in the term of office of the Trustees has been recorded in the minutes of the meeting. Save and except the aforesaid the present Trustees have not taken any other steps including obtaining the written requisition of the majority of the members of the Anjuman Committee and making application before the learned Judge in Chambers for suitable amendment and modification in the said Scheme for reducing the term of office of the Trustees as stipulated in Rule 25 thereof.
- 12. My client further states that she has been repeatedly raising the issue of reduction in the term of office of the elected Trustees from seven years to 5 years. However the Trustees have a vested interest in the continuance of the term of office for seven years and as such they have been reluctant to take all

- necessary steps in that direction. My client has been addressing online queries and informing the members of the Anjuman Committee through her write-up in the news tabloids. She has received an overwhelming response as to the amendment in the said Scheme for reducing the term of office of the Trustees. In this connection
- 13. My client further states that by her letter dated 17th August, 2021 addressed to the Trustees and the CEO of the said Trust reminding the Trustees to ensure that the necessary written requisition of the majority members of the Anjuman Committee be obtained and in pursuance thereof submit necessary application to the learned Judge in Chambers of the Hon'ble Bombay High Court for suitable amendment and modification of the provisions of Rule 25 of the said Scheme for reducing the term of office of the Trustees from seven years to 5 years before the holding of any further election for the office of the Trustees. In the said letter she has emphasized that the issue of reduction in the term of office of the Trustees be given priority and the same should be given effect prior to the holding of any further elections.
- 14. My client further states that although the said Trust and its Trustees have duly received the said letter dated 17th August, 2021 by E-Mail of my client, the same has been deliberately not responded, replied and/or complied with. In the circumstances my client has been gathering response from the members of the Anjuman Committee through Whats Aap groups and other online portals on the specific issue of reduction of the term of office of the Trustees from seven years to 5 years as the elected Trustees of the said Trust. My client has been receiving an overwhelming response and as such the majority of the members of the Anjuman Committee are of the view that the term of office of the Trustees should be reduced to 5 years at the earliest point of time. In the circumstances what is required is for the said Trust and its Trustees to obtain the written requisition

from the majority of the members of the Anjuman Committee and submitting necessary application for amendment and modification of the provision of the said Scheme for reducing the term of office of the elected Trustees.

- 15. My client further states that in the absence of any such step being taken by the said Trust and its Trustees to reduce the term of office of the Trustees, my client will be compelled to initiate a campaign and also make suitable efforts to obtain the written requisition of the majority members of the Anjuman Committee and approach the learned Judge in Chambers of the Hon'ble Bombay High Court in the manner contemplated under the provisions of the said scheme. However my client hereby once again remind the present Trustees of their commitment and their duty towards the members of the Anjuman Committee on the issue of reduction of the term of
- office for a period of five years instead of the existing seven-year term under the said Scheme.
- 16. In the aforesaid facts and circumstances I have been instructed to call upon you, which I hereby do, to forthwith take all necessary steps required under the provisions of the said Scheme for the amendment and modification of Rule 25 thereof for the reduction of the term of office of the Trustees of the said Trust on urgent priority basis before the holding of any further elections of the Trustees, failing which, my client will be compelled and constrained to adopt appropriate proceedings under the said Scheme, which please take urgent and serious note of.

Reference:-- Free Press Journal Advertisement dated 10th April-2021 calling for objections in the matter of SDA no. 10/812/2021 for registration of a Trust called "Global Council of Zoroastrian Trust", filed by Shri Burjor Hormazji Antia.

We would like to record our objections to the registration of the above-mentioned Trust on the following grounds:-

- In India, the Followers of the Zoroastrian Religion are known as the Parsis, or better still for more clarity, the Parsi Zoroastrians, both having one and the same meaning. The Parsis had migrated from Iran to India more than 1300 years ago in the wake of the religious persecution.
- 2) Since about last century, several Parsis started migrating from India to U.K., U.S.A., Middle-eastern countries and to Australia, New Zealand, Hongkong and other countries. In recent times, some of these Parsis, having acquired wealth and power, prefer to call themselves only as 'Zoroastrians', and not as 'Parsis'. All such people outside India have formed their own associations there.
- 3) In India, particularly in Mumbai and in Western parts of the country, the Parsis did flourish and also acquired vast properties, particularly for the purpose of having religious ceremonies, and for residential purposes also as a social cause. In India, the places of worship for the Parsis are known as the "Fire-temples" and practically all of them are

being CONSECRATED ones, and the Fires installed in them through elaborate ritual ceremonies. This is a unique feature only for the Parsis living in the Indian sub-continent. Nowhere else in the world are there any consecrated firetemples. These fire-temples therefore also require roundthe-clock ritual ceremonies, and the Trusts are formed for the maintenance of the same.

- 4) Now in recent times, it so happens that some of these so-called 'Zoroastrians' only from outside of India, are reportedly trying to gain access to all the institutions and properties of the Parsis in India, trying to foist their own agenda by manipulating the tenets and traditions of our religion; and also to weaken and erase the PARSIIDENTITY of India. One has to remember that even at present the Parsis of India form the largest group in the world among the followers of the Zoroastrian Religion.
- 5) The formation, therefore, of the so-called Global Council of Zoroastrian Trust, is an attempt to influence the Parsi interests in India by such elements as mentioned above, in collaboration with some of our local leaders, by trying to register such a Trust in Mumbai without taking into confidence the Parsi population of India. We have already what is known as the Bombay Parsi Punchayet, which is a sort of an apex body for the Parsis of Mumbai as well as those in other parts of India. There are also more than 80+ Associations all over India representing the Parsi community in different places. We have a practice of summoning Public General Meetings in case of serious matters concerning the interests of the community. In the matter of the registration of the said Trust, the contents are not properly discussed among the Parsi public at large, nor with all other associations individually. It is only discussed at the meetings of some of the representatives of these organisations, some of whom may have vested interests, and others might be compelled to fall in line. Even when some of the community activities have asked for the relevent documents for the said Trust, they have not been given access to the same.
- 6) You may notice that there is no term "PARSI" in the nomenclature of the said Trust presented for registration. We feel that our Parsi community in India do not require such a Trust at present.

We therefore request your goodself kindly to request the organisers of the said Trust to discuss the same properly among the Parsis of India.

Sunny Side Up- When cooked perfectly, this egg is crispy & firm at the edges but the yolk is soft & runny.

Similarly learn to be firm & stick to your decisions once you make them but also still stay fluid to change & filled with warmth at your center.

Parsi Akoori- Nothing beats a good morsel of creamy Akoori served on top of Brun pav. However, take the same ingredients & overcook it & you will not get Akoori but Bhurji which tastes rubbery &

Similarly, if you overthink a decision for too long you are going to ruin it. Instead, remember to combine what knowledge you have, think over it a bit & then just take action!

Salli per Eedu-

I make Salli per Eedu the same way for you

as my mummy did & she used the same recipe her mummy did.

There is value in experience & doing things the traditional way.

In a world that is fast changing, it is easy to discount tradition for ancient ideas, but remember to question yourself on the reason why someone is still doing it the way they were 50 years ago before you go ahead & change for the sake of it.

Cheesy Omelette- Did you know the first word you spoke was not Maa or Daa, but 'Cheesh' (I was so proud). A good cheese omelette needs only two things - cheese & eggs. Most days if you use a salted cheese you won't even need seasoning!

Remember, that the good things in life don't need to be overly complicated. On most occasions if you have love & honesty by your side, you are sorted.

Tarkari per Eedu- We Parsis have an innate ability to take any leftover vegetable, add an egg on top & turn it into an entire new dish.

Be versatile like this dish because there are many different versions of the 'perfect you' & if you can keep tweaking & adjusting to what's needed, you will always be in fashion.

Baked Eggs with Truffle Oil- Sometimes all you need is a small quantity of something special to make a common dish spectacular. Try to be this 'Truffle Oil' in life which adds a sparkle to the everyday hustle.

All you need to do for this is think a little out of the box (& of course then go ahead & implement it).

Egg Curry-

I am not a big fan of Egg curry but your Mamaiji has spoken to me of many days as a child when her parents couldn't afford meat & so dinner would be egg curry.

Above I spoke of, taking & adding small amounts of 'something special' but sometimes even that is not needed & just a humble egg can also make an ordinary meal special.

So, while fancy is great, you don't always have to wait for inspiration to strike, simple can also be good enough.
