

THE COMMUNITY WEEPS FOLLOWING A COMPLAINT BY KERSI RANDERIA, CONVERSION OF LEAVE AND LICENSE TO TENANCY HAS BEEN STAYED

Kersi Randeria has succeeded in bringing about a stay on the conversion of Leave and Licenses to tenancies.

Historically, it is very rare that the BPP Trustees who have made commitments actually stick by them after elections. The current Trustees had a gem of an idea to convert all leave and licenses to tenancies. This was on the election manifesto of nearly all Trustees.

To act of their commitment, three Trustees (Viraf Mehta, Armaity Tirandaz and Xerxes Dastur) passed a groundbreaking resolution on February 21, 2022, permitting all lawful licensees to convert their leave and license agreements to that of tenancy by paying the statutory stamp duty.

When this issue was brought up before Justice Kathawala and Justice Jadhav by certain individuals not in favour of conversion, including Trustee Kersi Randeria, the Court was of the view that if the individuals felt a wrong action was being taken, they could consider moving the High Court (Chamber Judge) for relief. However, no one challenged this decision.

However, we now have learnt that the

Election Commission of the ongoing elections has put a stay on the resolution passed by the Trustees on February 21, 2022 on conversion of leave and licenses to tenancy. The stay has been put by the EC pursuant to a complaint dated March 24, 2022 filed by Kersi Randeria who has opposed the resolution passed by Viraf Mehta, Armaity Tirandaz and Xerxes Dastur.

It is our view that politics that takes away benefits to the community should be frowned upon. The community had the golden opportunity to allow the conversion of all lawful leave and licenses to tenancies so that all beneficiaries can be secure and safe in their home without the fear of eviction. This opportunity seems lost for now and no one except the community beneficiaries shall weep.

Please also forthwith intimate in writing to us whether you were made aware by any BPP Trustee or BPP staff member of the directions issued by the Election Commission dated 24th March 2022 to the BPP trustees not to issue any Public advertisement/news item in this regard.

You are requested to provide the aforesaid information not later than 29th March 2022 by noon under any circumstances.

The Election Commission reminds you of the personal Undertaking given by you to the Hon'ble Bombay High Court, and the inclusion of your publication in the Order sanctioning the Election Scheme dated 1st March 2022 passed by the Hon'ble Bombay High Court.

The Election Commission will be further investigating the matter which prima facie appears to be an attempt to circumvent the directions of the Election Commission.

1. At first, I would like to unconditionally apologize to the Election Commission if our 27/March/2022 edition of Parsi Junction has caused any hardship to you, due to any misunderstanding or otherwise. Every story has two sides and within the community our aim is to provide what we think is the right side of the story in keeping with our motto of transparency and accountability.

The article with the title **BPP BOL** is something we have been using for much time now to let the community know interesting new items of the BPP, the apex Trust of our community. These are our views only. We have never proposed for anyone to think that this is from the BPP and there is no complaint against this ever.

The hot topic of conversion of leave licenses to tenancies has been in the news for quite some time, right from 2018 till date. In fact in the past, two Trustees have also published articles oN this topic with us. Other Trustees have published articles on this topic in other papers. The view of the paper is that tenancies should be given to all as long as the Trustees can keep the colonies for Parsis only. We have stated this in the article and this is the view we published.



Mrs. Maharukh Noble has worked in the shadows of her own success for decades. Her commitment to serve the less-privileged of our community has been at the forefront of her resolve and she now wants to take these initiatives through the BPP.

Mrs. Noble has spent more than half her life serving the less fortunate and needy of our

community. It all began under the influence of Late Mrs. Silloo Kavarana, fondly remembered as the Florence Nightingale of the Parsi community. Mrs. Noble spent a good part of a decade working at the Red Cross with Mrs. Kavarana, after which there was no turning back.

Maharukh Noble has been a silent worker for decades but her repertoire speaks volumes. She has been on the Ladies Committee of the Parakh Dharamshala for over fifteen years helping those who have been forgotten by their own families. She has been on the Managing Committee of the Ratan Tata Institute (RTI) for almost fifteen years

and for the last five years, she has been a Trustee at RTI. . She is also the Managing Trustee of the 119 year old Stri Zarthosti Mandalthat is synonymous with providing doles to the poor, education aid to the needy and medical aid to the less fortunate. The Mandal not only distributes food grains, Sadra, Kusti and other necessities to the poor living in the interiors of

Gujarat but has also constructed borewells and provided electricity connection to families staying in villages.

Through the Zarthosti Mandal, Mrs. Noble has single-handedly spearheaded the Adopt-A-Mobed scheme to provide monthly hampers to the Priests of our community as a token of thank you for the yeoman service they provide us.

Mrs. Noble is not just religious but believes in preserving our religious institutions too.

As part of the Kar Seva group she has actively help organize and participated in the cleaning, repairing and painting of the Agiaries and Aatashbehrams. So far the Ranji Agiary at Grand Road, the Soonaiji Agiary at Gowalia Tank and the Ashburner Agiary at Khetwadi have been the recipient of this groups efforts.

It is well know that Maharukh Noble holds Community Welfare very near and dear to her heart. Her latest contribution to the community is the Dr. Nelie Noble Medical Center at Khareghat Colony. Not only did Mrs. Noble provide the funds required to repair, renovate and design the medical center, she has also committed to a monthly contribution towards the running of the medical center for the next few years. This magnanimous donation will alleviate the concern of the Parsi/Iranis in that area of the lack of doctors in colonies to provide death certificates.

> and whenever needed. He stepped up to the plate when vaccinations began and got hundreds of Parsi families priority to get their shots easy and fast. He is especially commended for the efforts he made towards the seniors of our community.

Rumy Zarir was felicitated with the '100 Most Impactful Corona Warrior Awards' by the Social Talks in association with Indian Drug Manufacturers' Association (IDMA) for services rendered during the lockdown to society at large.

Rumy has been appointed as CEO OF Zoroastrian Building Fund where he is doing a very commendable job to look after the welfare of all the residents of Chikalwadi complex at Tardeo.

Rumi has been a silent worker through out his life. When we learnt of his contribution towards our community we were shocked and yet immensely impressed.

Rumy was one of the key individuals involved in Thooti Agiary encroachment issue and was instrumental in sorting the matter by endlessly following up with local authorities for over six months. He ensures the sliding gate illegally made by the neighbouring society was completely demolished. He also made sure that the parking spaces were freed up for Parsis visiting the Agiary which were also illegally encroached upon.

Rumy also helped o save the Eedawalla Agiary situated at Marine lines by halting the construction of a public lavatory outside the Agiary. The same was then demolished after filing a written objection and several follow-ups with the BMC authorities.

When the need to preserve our culture and heritage arises, Rumy will always be in the forefront and will march on towards making it happen. Some people dream of success, while other people get up every morning and make it happen. In the coming weeks we will show you how Rumy Zarir has performed feats far greater than our community is aware of.

NEW HOME FOR SENIORS

A new 16-studio, ground-plus-one-storey, Healing Touch, Senior Citizens Home at Village Garade, 23 kms from downtown Poona, has been started by ex-merchant navy officer Capt Adi Mistry on March 5, 2022. At present nine seniors are set to reside in the apartments that are "fully furnished with everything from toilet paper to geysers," he notes. Facilities include a big recreation room, with a 48-inch television set and "almost all basic indoor games... The land has a long

walkway, with huge trees, all along the roads... We plant about 300 trees every year," Mistry stated. Wife Khurshid manages the staff.

Rooms are available at a predetermined price, and mostly on sharing basis. "The basic amount starts with about Rs 36,000 per month and gradually comes down to Rs 18,000 per month for



long-term residents," noted Adi. "This can reduce further if we get donations... We can increase the number of senior citizens by building more infrastructure, as I have more plots."

"I have already invested about four crore rupees to fulfill my mother's (Shera) dream, wish and command," the 72-year-old Adi stated. "Dikra kai bhi karé tau buddha o né sambhaaljé, dua laagsé (Whatever you do,

take care of the elderly... you will receive their blessings)," the senior lady reportedly told Adi. "I have prospered... séva karu tau su khottu chhè (what is the harm in serving)?" he told us.

ARMAITY RUSTOM TIRANDAZ Proposed by: Mrs. Zarine Daruwalla Seconded by: Mrs. Zarine Engineer

Mrs. Armaity Rustom Tirandaz is the flag bearer of our community. She has been a Trustee of the BPP for 13 years and the Chairperson since Jan '21 . And by god her service to the community is par excellence.

XERXES VISPI DASTUR

Xerxes – the Trustee who kept all his commitments.

When he contested to be elected in 2018, Xerxes committed to resign with the rest of the Board in October 2022 giving up 3 years of his 7 year term. Being a man of his word, he is stepping

down in just 4 years as a Trustee of the BPP in May 2022 with the rest of the Board as per his commitment and standing for re-elections. By doing so, he has single handedly saved the community Rs. 40 Lakhs of Trust funds which would have been spent on a mid-term election.

When he was appointed in 2018, Xerxes along with the support of Chairman Tirandaz and fellow Trustee Viraf Mehta fought to remove extra service charges of Rs. 750/ pm that had been ruthlessly levied on community colony residentsby the then majority Trustees to cover up for loss of revenue due to his wrong policy of not auctioning even high value flats.

Finally in 2020, Xerxes prevailed and kept to his election commitment to remove the additional service charges of Rs. 750. This reduced the burden on the community members many of whom were poor and yet being threatened, illegally, to either pay the service charges or face eviction from their homes.

His commitment to convert Licensees to Tenants was not allowed to be fulfilled either



by the then majority Trustees. But when the tide changed with the Majority now being led by Armaity Tirandaz, the Trustees decided to convert lawful Licensees without any baggage to Tenants after obtaining legal opinion from the Solicitor firm of Mull and Mulla and DSK Legal.

Xerxes Dastur has an exemplary career so far. He

is an auditor of various Parsi Trusts, Agiaries and Atash Behrams. He is also the Trustee and Chairman of the Managing Committee of the Ripon Club, President of the Bombay Parsi Association, Chairman of the Mumbai Chapter of the World Zarthusti Chamber of Commerce, Member of the International Board of the World Zarthusti Chamber of Commerce to name a few.

To add to the many feathers in his hat, he is also the President of the Sir Ness Wadia Memorial Pavilion and the treasurer of the Rustam Baug Welfare Association.

Being a Chartered Accountant by profession and running his own company, V.S. Dastur & Co., Xerxes' penchant for fiscal efficiency cannot be matched. He was quick to join Yazdi Desai in managing the accounts of the BPP and post Yazdi's resignation, he has taken charge. It is another story that the BPP's financial condition was dire even before Xerxes became a Trustee but kudos to him for helping in keeping the Trust above water. The next few weeks will show.

VIRAF DINSHAW MEHTA

Viraf is probably the most outspoken Trustee on the right side of the spectre.He is honest and hardworking and despite being the youngest Trustee in the BPP, he has stood shoulder to shoulder with peers clearly showing us that age is just a number.

As Vice-President at one of Asia's leading Investment Group, Viraf has amassed over two decades of experience in the capital markets



and currently heads his own trading team. Despite that, his contribution of time and dedication to his community and especially the beneficiaries of the BPP is unparallel.

He is loved and hated for being the son of the ex-Chairman and community stalwart Mr. Dinshaw Mehta.

But despite his nay-sayers and detractors constantly trying to pull him down, he has managed to clear every hurdle with sincerity and humility.

Viraf Mehta has had a torrent first term where he spent the first half fighting to simply get his basic right to information as a Trustee Both he and Mrs. Tirandaz were denied access to all papers, agenda, minutes, documents, legal or even any BPP accounts. Having no choice he and Mrs. Tirandaz were forced to eventually move the Bombay High Court to get an order directing all information to be provided to all Trustees. The HIGH Court whilst castigating the dictatorial behaviour of the then majority Trustees, ordered them to treat Mrs. Tirandaz and Mr. Mehtaas equal Trustees. While the huge legal cost of this hearing was borne personally by Mr. Mehta and Mrs. Tirandaz, the then majority Trustees charged their legal bill of almost Rs. 70 lakhs to the BPP and misused the much needed community charity funds to settle a inter-Trustees dispute.

Viraf Mehta, like his father, has earned the reputation of being the go-to person for anything a community member may need. He is caring and compassionate. He listens patiently and does not hesitate to call a spade a spade.

One cannot ignore the proactive approach of Viraf Mehta during the Covid pandemic which lasted for almost two years. Besides being part of the team at the BPP that was responsible to ensure that all the poor and weaker sections were fed lunch and dinner by setting up a kitchen in Cama Baug, he single handedly took on the responsibility of co-ordinating with the Parsi General Hospital to provide the first vaccine shot for everyone in our community, whethere living in a colony or not. He also gave his personal guarantee to the Hon'ble Bombay High Court to hold the Farvardin prayers at the Doongerwadi in September 2020 for the benefit of the community Members Trustee Xerxes Dastur was the only other Trustee who stood shoulder to shoulder with Mr. Mehra on this day. Viraf Mehta is the architect for ensuring the conversion of all Leave and Licenses to tenancies. But unfortunatelyat this point, Trustee Kersi Randeria has opposed this and filed a complaint with the Election Commission and obtained a stay on this issue. We are certain with the right board elected, they will do what is right to ensure all lawful leave and licenses are converted to tenancies.

Given the financial distress the BPP is in, Viraf Mehta along with Xerxes Dastur and Chairman Armaity Tirandaz resumed the Auction of High value flats which had been stopped by the earlier majority Trustees. Before his resignation, late ex-Chairman Yazdi Desai had also seen the merit in this and had changed his mind to now allow such auctions. This has once again brought much needed funds in the coffers of the BPP. . Not only does the BPP benefit from this but the outgoing Tenants are allowed to encash their tenancy whilst allowing a new family to start their life in a Parsi colony.

The next few weeks will layout a road map for the revival of the BPP beyond the past debacles it faces.

- 13) Use the BPP website more efficiently to streamline basic processes
- 14) Look into the community wide group Insurance plan which the BPP has not been able to do because of lack of finance

DOES NOT AN INCREASE IN SALARY AMOUNT TO AN INDUCEMENT TO VOTERS? – asks DR. ZULEIKA HOMAVAZIR

I was informed that the BPP Trustees are in the process of increasing the salary of the Class IV workers by over 20% and its cumulative effect considering Provident Fund, various leaves and other indirect costs would lead to atleast 25% increase in wage bill every month. I was very surprised at the timing of the decision to increase the salaries, especially when a new Board of Trustees is to take office within two months on May 29, 2022.

Suspicious into the action of the Trustees, I inquired into the number of Class IV workers (Zoroastrians and non-Zoroastrians). I was shocked to learn that:

there are a total of about 220 Class IV Workers, of which: a total of about 25 are Zoroastrian (Khandiyas) and A total of about 190 are Non-Zoroastrians, comprising gardeners, security staff, peons, pumpmen, most of them being unskilled category.

The Board of Trustees is seeking to increase the salary of all the above 220 workers.

In my view, the salary of Class IV Zoroastrian workers, predominantly our Khandiyas should be increased far more than just 20%. It is injustice that inspite for all the services rendered by them, they are only given an paltry increase of just 20%, which is what all the unskilled Class IV Workers also will get.

The Khandiyas are the backbone and gateway to our deceased.

Clause 8.13 of the new Scheme of Elections clearly defines the role of the Election Commissioners to conduct Elections with Transperancy and to conduct free and fair elections.

The Zoroastrian Class IV employees and their family members are being enticed by clearly increasing their salaries and concurrently their perks by the current Trustees. IS THIS FAIR TO THE OTHER CONTESTANTS?

PRIMARILY THE NON-ZOROASTRIAN CLASS IV EMPLOYEES SUCH AS GARDENERS, SECURITY, PEONS ETC. SHOULD HAVE BEEN CONTRACTUAL.

WRONG POLICIES AND DECISIONS THEREON HAS CULMINATED INTO THIS CONSISTENT PROBLEM EVERY TIME THE AGREEMENT IS TO BE RENEWED WITH THE UNION.

DURING THESE TIMES OF RECESSION, WOULD ANY CORPORATE GIVE THIS HANDSOME RAISE OF 25% IN SALARIES?

However, this increase must not be done by the present Board of

Trustees as any increase in salaries today would undoubtedly amount to an inducement for them to vote for the current Trustees.

Any decision to increase must be taken by the new Board and the Class IV workers be paid arrears for the time worked under the existing contract.

At present the monthly salary bill is around Rs. 1.1 Crore and that too without Overtime. With the anticipated 25% increase negotiated with the Union, it means the monthly wage bill would now be Rs. 1.375 crores and yearly wages amounts to Rs. 16.5 Crores. Thus a huge amount of Parsi Charity funds of Rs. 16.5 crores is spent on staff. And once again to offset this huge increase the Trustees would again have to increase Service Charges by Rs. 1000/ to Rs.1500/ pm from all the Parsi beneficiaries thus imposing this cost to Parsi residents of all our colonies who will have to pay to satisfy the demands of the Union.

Why not let the new Trustees who will take office next month on 29-5-2022 negotiate the increase in salary as they will be in charge for the next five years whilst the present Trustees term will expire in close to a month.

It is worth mentioning at this stage that the wage bill of non-Zoroastrian Class IV Workers is about Rs. 70 lakhs pm, Zoroastrian Khandias is about Rs. 7 lakhs pm, BPP Superior staff most of who are Zoroastrians is about Rs. 25 lakhs pm and other retired office staff on Contract is Rs. 10 lakhs pm. Thus totaling Rs. 1.12 Crore a month.

At present without the new settlement, A Khandya earns around Rs. 40,000/ pm TO Rs. 27,000/ pm without overtime and about Rs. 55,000/ pm to Rs.30,000/ with Overtime, besides other Royalties being paid to them.

A Class IV worker earns from Rs. 40,000/ pm to Rs. 30,000/ pm without overtime.

I had complained to the Election Commission regarding these steps of negotiations with Union taken by the BPP. Unfortunately, my complaint has been peremptly rejected by the EC, without providing me an opportunity to be heard.

I have always believed in transparency and in this commitment, I had copied my complaint to all the Parsi press so that they are made aware of the facts.

My complaint and response from the EC directly dismissing my complaint has already been published in the last issue of Parsi Junction. I have since then, written to the EC seeking clarity as to the process which the EC intends to follow for all complaints and whether it is appropriate for the EC to dismiss my complaint without providing me with the opportunity to be heard. A response is awaited.

My service to the Community will continue despite this action by the EC permitting the Trustees to increase the salary of workmen, including the 25 Zoroastrian khandiyas who will now be indebted to the Trustees and this is an inducement for votes.

Aside from increase in Salary, other incidentals is to pay for mediclaim of the Class IV Workers, marriage gift, long service reward, retirement gift, funeral expenses of family member at Rs. 7000/, shoe allowance of Rs. 1200/, Bonus of 40 days, etc.

What takes the cake is giving a donation of Rs. 7 lakhs to the Union over three years. A novel proposal.

As the Complaint was dismissed, without providing me with an opportunity to be heard, I inquired with the EC on the process it intends to follow relating to EC Complaints. No response to my query has been received.

DISPOSING OF URGENT COMPLIANT: Complaint to Chief Election Commissioner

Dear Sir,

I am in receipt of your email informing me that there is no need to intervene in my complaint.

The scheme of elections mandates that all decisions taken by the EC need to follow the principles of natural justice. I note that the contents of your email below have been passed without giving me the opportunity of being heard, which in itself is in violation of these principles.

For the sake of clarity and transparency, may I kindly request the EC to inform me (as well as the Community) the procedure that is going to be followed by the EC upon them receiving complaints under the scheme of elections.

This request is being made to ensure all complaints made to the EC are heard and decided in the same manner.

IT IS HOPED THAT THE CEC WILL RECONSIDER HIS PEREMPTORY REJECTION WITHOUT GIVING ME A PERSONAL HEARING IN THE INTEREST OF NATURAL JUSTICE AS LAID DOWN BY THE DIVISION BENCH OF THE HIGH COURT AND GIVE ME A CHANCE OF A PERSONAL HEARING TO CONVINCE THE COMMISSIONERS.



PROTOCOL FOR COMPLAINTS OR GRIEVANCES BEFORE THE ELECTION COMMISSION [EC]

- EC will adjudicate any complaint relating to the election arising from an alleged breach of the Scheme for the Election and/or Code of Conduct [CoC].
 A complaint or grievance in writing will be entertained by the Election Commission if-
 - A complaint or grievance in writing will be entertained by the Election Commission if (A) Made by a person whose name appears in the General Register or Donor Register including candidates and Trustees; and emailed to electioncommissionbpp@gmail.com. No other means of communication will be accepted.
 - (B) Complaint must contain:-
 - i. Full Name and address of the Complainant along with Complainant's membership number as on the Certificate of registration issued by the BPP.
 - ii. Scanned copy of the Aadhaar Card
 - iii. Particulars of the occurrence/event leading to such complaint
 - iv. Name of the person/s against whom the complaint or grievance is made
 - (C) Shall be made at the earliest possible time from the occurrence complained.

3. PROCEDURE UPON RECEIPT OF COMPLAINT

- (1) EC shall in the first instance examine whether the complaint received falls within the EC's authority /role under the Scheme; if the EC is of the view that the Complaint falls outside its authority or scope, the Complainant will be notified that the complaint cannot be entertained.
- (2) In the event the EC is of the view that the complaint so received falls within the EC's authority /role under the Scheme; the EC will issue Show Cause Notice along with a set of the complaint and supporting documents to the person/s against whom the Complaint or grievance is made ("Respondent"), to enable such Respondent to furnish a reply to the same.
- (3) The Respondent shall reply to the complaint and the allegations made therein and send it to the EC, with copy to the Complainant within 4 [four] days from the date of receipt of the Complaint by the Respondent.
- (4) On receipt of the Reply from the Respondent, the EC will examine the complaint based on authenticated evidence provided by the parties and call for a hearing by email on any working day (Monday to Friday) during working hours (10 am to 4 pm) only. At the hearing so fixed, neither the Complainant nor the Respondent are entitled to be represented through an Advocate, or any Constituted Attorney.
- (5) The EC has the discretion to grant such relief as it deems fit.
- (6) The Complainant and the Respondent shall be informed of the EC decision (reasoned and in writing) within 14 [fourteen] days or such time as may be extended from the date of receipt of the Complaint.

4. POWERS OF EC

- (1) The EC, appointed by the Bombay High Court, is the final authority on all aspects concerning the holding of elections; and the EC's directions, orders and instructions shall be obeyed by all persons including candidates, Trustees, BPP staff, without demur or reservation, in all matters relating to elections and electoral process, as provided under the Scheme sanctioned by the Bombay High Court.
- (2) Under the Scheme, the Chief Election Commissioner ('CEC') is empowered to declare the election of any candidate as invalid for breach of the Scheme of CoC; as also to declare any serious breach as 'corrupt electoral practice', which may result in a candidate's election being invalidated.
- (3) Apart from the power to invalidate an election, the EC may issue such other directions or orders as are necessary to remedy the breach of the Scheme or CoC.
- (4) Any decision to invalidate the election of a candidate shall not be effective for a period of four weeks from the date of such decision; and is subject to challenge before the competent Court.

"Finally, the election process for seven trustees of the Parsi punchayet has commenced with the closing of nominations! For this, the community needs to thank retired Justice Sharukh Kathawala for burning the proverbial midnight oil, perhaps for the last time in his illustrious career as a Judge of the Bombay High Court.

It was a pleasure to view videos of Justice Kathawala being felicitated by the Bombay Bar Association on the eve of his retirement when he demitted his office on the last day. Our Bombay High Court has had some of the finest judges and continues to have them today too and like many of his predecessors, he has most certainly carved a niche in the portals of the High court!

As in most matters, almost every judgment results in controversies and has supporters and opponents!

There are voices and WhatsApp messages congratulating Justice Kathawala and suggesting,



that now that he has retired, he should offer his services to the community as a trustee of the BPP. However, there are a few disgruntled voices who, after a detailed perusal of the amended scheme and the filing of nominations by some individuals, are wondering, whether the amended scheme was framed by high profile senior counsel at the behest of some trustees to accommodate certain candidates of their choice while disqualifying some others! The age-old procedure for amendments to the scheme has been that the trustees discuss, deliberate, and then finalize any amendments to the scheme and after giving 4 days' notice to the Charity Commissioner, approach the Judge-inchambers for approval. This provision continues even in the scheme just amended. Strictly following this prescribed procedure would have allowed an aggrieved party to appeal before the Division Bench. It is a common perception that Senior Counsels with their expertise and skills are masters in arguing their stand and one needs to understand that Judges too are human and judgments/orders are based on facts as presented before the learned judges. After all, it is humanly impossible for judges to read the minds of litigants and decipher hidden agendas if any.

What started as a minor amendment of reducing to two terms of 5 years each for trusteeship has ultimately resulted in a major change in the whole scheme."
